A bid was also received from Bickel Tree Service for \$1,500.00 per tree. The bid was conditionally accepted if work completed prior to October 31, 2018. Trustee Bugos seconded. G2018-63 Trustee Bugos made a motion to eliminate the reading of the previous month's minutes aloud at each Regular meeting. The previous month's minutes will be posted to the township's website and will also be available at the township meeting for residents' perusal. The posting and hard copy will be marked "Unofficial" until such time as the Board of Trustees approves or amends them at the scheduled monthly meeting. Trustee Emerine seconded. G2018-64 Trustee Bugos made a motion to accept the Amended Official Certificate of Estimated Resources dated August 14, 2018 in the amount of \$4,582,208.97. This certificate includes the newly created 2902 Mosquito Control Grant in the amount of \$2,500.00 and closes out the 2901 FY 2016 Mosquito control Grant fund as required due to the change in the amount. F2018-65 Trustee Emerine made a motion to accept an Ohio BWC Safety Intervention Grant for the Fire Department in the amount of \$36,072.44. This amount will be used toward the total cost of \$48,096.59 to purchase a power patient cot and loading system for Squad 21. The Fire Department local share will be \$12,024.15. Trustee Bugos seconded. Bugos yes, Emerine yes, Fee yes.

F2018-66 Trustee Bugos made a motion at the request of Fire Chief Hickey to purchase a 2019 Sutphen Monarch Custom Chassis Fire Engine from Herb Fire Equipment of Powell, Ohio, in the amount of \$442,160.54. The purchase shall be made with the Ohio State Term Schedule, #800257, and includes a 100% prepay discount on the truck. The full amount before prepay discount is \$448,893.95. Trustee Emerine seconded. Bugos yes, Emerine yes, Fee yes.

F2018-67Trustee Emerine made a motion at the request of Fire Chief Hickey to approve financing of the proposed purchase of the 2019 Sutphen Monarch Custom Chassis Fire Engine from Herb Fire Equipment of Powell, Ohio. The Champion Township Board of Trustees shall enter into an agreement with Community Leasing Partners of Manhattan, KS, a division of Community First National Bank, to finance the fire engine purchase in the amount of \$442,160.54 at an annual percentage rate of 3.71% for 10 years. No early payoff penalty or fees apply to this loan. The annual payment made by the Fire Department on this loan will be \$53,742.21, with the first payment due one year from closing on the loan. Trustee Bugos seconded. Bugos yes, Emerine yes, Fee yes.

G2018-68 Trustee Bugos made a motion at the request of the Auditor of State's office to allow the use of blanket certificates, expiring no later than the last day of each fiscal year, to be limited to \$10,000.00 or the maximum amount of appropriation, whichever is less, and any blanket certificates requested to be issued in an amount over \$10,000.00 shall be requested by a resolution at such time as needed. Trustees will still be required to sign each blanket certificate. Trustee Emerine seconded. Bugos yes, Emerine yes, Fee yes.

Trustee Emerine made a motion at the request of Fiscal Officer Hatt to look into optional OPERS Life Insurance through Colonial Life for eligible employees. Employees would bear 100% of the cost of this life insurance plan. A representative will be available should Township employees be interested. Chairman Fee turned the floor over to resident, Debbie Christ for comments on the update on 356 Lauder. Christ also spoke to issues with regard to the collection of delinquent taxes within the Township and questioned whether or not the Trustees were utilizing the land bank and the publishing of a list of the delinquent properties in the newspaper.
