Steve and Carnan Bergren reviewed some history of the water district, which currently has 240 customers and 2 warehouses using the system.

The first of the meetings held to obtain public input will be held on November 16, 2018 at 9 am. There was discussion of the need to have meetings at a time more convenient to allow the working public better access.

Steve will post the PUD report on the Peshastin website for review.

An audience member suggested including information about the water system and upcoming meetings in the monthly water bill mailing.
