

Traditional Funeral with Burial

Basic Services of the Funeral Director and Staff

\$2,300

This service charge reflects the duties of the funeral director and staff attendants who assist your family through the grieving process. The duties include clerical, administrative, and professional skills that only a funeral director can legally provide, as well as initial caretaking and sheltering of your loved one at the time of death.

Professional Services by a Licensed Funeral Director

Embalming \$700

We offer this service to provide temporary preservation of the body and to reduce potential internal and external health hazards.

Preparation of the Body, Dressing, and Casketing

\$400

Washing and disinfecting of the body, professional attiring of the body with clothing provided by the family, arranging the body in the casket, and basic cosmetology. External hair stylists and make up artists require additional fees.

Reconstruction, Autopsy, Organ Donation Repair

\$250

This service is provided by a licensed embalmer when a body may need cosmetic reconstruction due to the cause of death, autopsy, or other post mortem medical activities.

Custody and Cooling

\$25

Daily surcharge for sheltering and cooling a body until burial.

Casket Selection \$995 - \$9,300

Prices are determined according to specific selection and personalizations by the family. A complete list is available on site for all merchandise present.

Outer Burial Containers

\$790 - \$3,496

A complete list is available on site for outer burial containers.

Direct and Immediate Burial

\$3,270

A direct and immediate burial (without embalming, visitation, or funeral) is comprised of the basic services of a funeral director and staff, and transportation to the funeral home and to the graveside. This does not include a grave opening/closing fee, nor does it include the price of the burial container.

Traditional Cremation Services

Direct Cremation \$ 2,400

A direct cremation is an economical selection for families who prefer a quick cremation without a memorial service. This service includes the Basic Services of a Funeral Director and Staff, the filing of all necessary legal and administrative documents, transfer of deceased to the funeral home, the cremation and associated fees, and a basic urn.

Cremation with a Memorial Service

\$ 2,700

The family may receive friends for two hours prior to a Memorial Service at Thomas Funeral Home. The Memorial Service is personalized per the family's requests. This package includes the Basic Services of a Funeral Director and Staff, the filing of all necessary legal and administrative documents, transfer of deceased to the funeral home, the cremation and associated fees, and a basic urn.

Traditional Funeral Service with Cremation Following

\$ 4,300

A traditional visitation and funeral allow a family to view the body and say farewell. The body is embalmed and casketed for visitation and viewing, and then cremated.

Please note that these packages do not include additional items such as certified death certificates, multimedia keepsakes, or personalized urns.

Commemorative Events

Traditional Visitation

A gathering for family and friends at our facilities or off location, staffed by our family attendant(s). Families may bring refreshments to share in our lounge.

Traditional Funeral Service

\$400

A service, at our chapel or at your preferred location, conducted by our professional funeral directors with music, minister(s), special musician(s) of your choice. Funeral directors will present and/or seal the burial container.

Memorial Service \$300

A service, at our chapel or at your preferred location, conducted by our professional funeral directors with music, minister(s), special musician(s) of your choice. Cremated remains will be present if possible.

Graveside Service \$200

Ceremony at the final resting place for burial, which can be private or public.

Grave Opening and Closing Fee

\$800 - \$850

We are pleased to offer this fee at cost. When able, we use R&B Graveservice to open and close graves. Unfortunately, some cemeteries require usage of their own crew and have separate fees. This fee is located on Professional, Administrative, and Cash Advances on your Statement of Goods and Services.

Audio-Visual Commemorative Experiences

Our chapel is equipped with two 80in screens with the capacity to share video tributes, still photos, recorded live music, and recorded special messages for families.

In the past, we have played video messages, well-wishes, and homilies from friends and ministers who are unable to be present for the ceremony. We are happy to live-stream services so that friends and families may join from any location.

These services are **complimentary** to families and are options to connect family and friends across the globe.

Please note: We promise to test your media messages thoroughly, and hope you understand that technology is imperfect. We offer these services to connect our families with their support system in every available capacity.

Transportation

\$275

Initial contact, custodial possession, and transportation from the location of death to funeral home within a 75mi radius.

Additional mile after 75mi

Utility Van \$100

This vehicle transports flowers, memorials, and other items from the ceremony to the place of internment.

Cemetery Van \$125

This vehicle is used by the private grave crew to carry materials to open and close the grave.

Receiving Custody of Remains

\$2,295

Receiving and collecting of an individual from another funeral home location. This fee does not include transportation costs or other funeral services.

Forwarding Custody of Remains

\$1,550

Retrieval, removal, and harboring the deceased and preparation for transfer to another funeral home location. This includes initial filing of paperwork with the state. This does not include transportation, airfare, or other funeral services.

Airline Container \$395

This is an airline approved container to use when shipping the body to another location.

Commemorative Media Collections

Each media collection provides a family with a variety of multimedia keepsakes in memory of the deceased. We created these personalized services so that your family can reflect on lifelong memories for decades to come.

Unfortunately, we are unable to utilize DVDs made by the family due to digital security purposes.

We are pleased to provide complimentary services such as: a magnetic photo board, an obituary posted on our website with a digital guestbook, social media posting to share, and live-streaming when desired.

We are happy to connect with local media stations (radio and newspaper) to announce an obituary, however each media outlet determines their own fee which must be paid by the family.

Classic Memories Collection

\$175

This collection includes a register book for guests to sign, acknowledgement cards, 75 memory folders of your choice, a personalized gravemarker card (to be used in additional gravemarker).

Enduring Memories Collection

\$255

This collection includes a register book for guests to sign, personalized signage, acknowledgement cards, 150 memory folders of your choice, a personalized gravemarker card (to be used in additional gravemarker), a video tribute with 100 photos set to music with a personalized design, 2 copies of the video, and a copy of the music from the ceremony.

Everlasting Memories Collection

\$375

This collection includes a picture register book for guests to sign, acknowledgement cards, 200 memory folders of your choice, a personalized gravemarker card (to be used in additional gravemarker), a video tribute with unlimited photos set to music with a personalized design, 4 copies of the tribute video, 2 copies of the music from the ceremony, a personalized bifold order of service for the funeral, a photo portrait for display, and digital access to a video recording of the ceremony.

We will contact the probate court on your behalf, place the order for the death certificates, and then retrieve the certificates for you so that you can complete all necessary paperwork.

Professional Services by External Parties

When a funeral is paid by valid insurance or by a payable upon death account, these fees will be cash advanced by the funeral home. Unfortunately, we are unable to finance these fees.

Grave Opening and Closing Fee

\$800 - \$850

When able, we use R&B Graveservice to open and close graves. Unfortunately, some cemeteries require usage of their own crew and have separate fees.

Officiant or Minister's Fee

\$100 - \$200

Musician's Fee \$50 - \$100

We are happy to recommend special musicians such as a bagpiper, trumpet, or other special musician for your personalized service.

Hairstylist's Fee

We are pleased to offer a variety of urns with the option to personalize each urn (such as engraved messages and laser engraved photos). Each type of personalization carries a separate fee that we will disclose prior to your order.

Urn Vault \$200 - \$495

This container is used when a family elects to bury the urn. The container is sealed and reinforced to protect the urn and cremains.

Keepsake Jewelry

For individuals who would like a personalized jewelry in memoriam of their loved one, we offer various types of necklaces, rings, charms, and other types of precious jewelry. We are also able to take the thumbprint of individuals for future use.

Each unique piece varies in price according to the price of the precious metal and item selected.

Additional Copies of DVD Tribute Videos

Each family receives a DVD Tribute Video in their selected media collection. Additional DVDs are \$5 per copy and are enclosed with a personalized disc cover and sleeve.

Payment Information

Payment is due at the time services are rendered. We are unable to finance goods and/or services. Absent a life insurance policy, a funeral bill is due no later than the date of the funeral.

Full payment is due no later than the date of the funeral, / / If payment is not paid when due, and unanticipated late charge of .75% per month (annual percentage rate of 9.00%) on the unpaid balance will be due. Life Insurance Policy

If an individual maintained a valid life insurance policy, the beneficiary can assign a portion of that life insurance policy to pay the final expenses. We are happy to verify and file the claim on behalf of the beneficiary.

Payable Upon Death Account

While the state of Georgia prohibits by law any prepayment of funeral expenses, we are able to work with families to create and close a Payable Upon Death Account at your preferred banking institution.

Check

We are able to receive checks from families.

Debit or Credit Card

We are able to receive payment by debit or credit card. There is a 3% processing fee for all cards.
