

President's Corner

In the mid-seventies to mid-eighties, neuropsychology was a developing toddler. NAN was formed in 1975 and the early neuropsychologists of that time spent much energy in developing this new field. They also anticipated that there would be a need for credentialing standards to determine a practitioner's competency in assessing cognitions and brain behavior. The prominent neuropsychologists, Dr. Lawrence Hartlage, Charles Golden, Robert Woody, Francis Fishburne, Theodore Blau, Jerome Sattler, Zygmunt Piotrowski, and others responded to this need for credentialing and formed the American Board of Professional Neuropsychology. Initially known as ABPN, it was incorporated in the State of Vermont in 1982. For the past 40 years, it has been an organization composed of neuropsychologists credentialing practitioners in neuropsychology, serving its membership, and promoting the field.

Since ABN's beginnings, there have previously been nineteen presidents and numerous members who dedicated their time to the service of ABN's members. Their voluntary service to ABN has been admirable. They made ABN a solid and stable organization with a voice in the neuropsychology field, seeking to advance the profession of the neuropsychologist. They were ordinary members committed to serving ABN's members. It is because of their self-sacrificing loyalty, we should be incredibly grateful for all those board members, secretaries, treasurers, directors, chairs, committee members, examiners, presidents, and all those members who committed their time, effort, and expertise in service to our organization.

This year we celebrate our 40th anniversary, and ABN continues to move forward in our field. We have maintained a steady flow of candidates seeking board certification. We are also in the process of working on our renewal application for CRSSPP recognition that is due in May of 2023. In September of this year ABN and AABN is sending delegates to the *Minnesota 2022 Conference to Update Specialty Education and Training Guidelines in Clinical Neuropsychology*, and we are also part of the Steering Committee for this conference. 

American Board of Professional Neuropsychology (ABN) Awards for 2021

Distinguished Neuropsychologist Lifetime Achievement Award (Research, Leadership, Training and Practice)

James A. Moses, PhD, ABPP (CN), ABN

Dr. James Moses has worked for more than 46 years which reflects a stellar example of a high level of scientific contributions and active practice, in keeping with the Boulder Model introduced at his 1974 doctoral alma mater. Impressively, he added the role of teacher and mentor for many of our well known neuropsychologists while adding many credits to public service. One would be hard pressed to find a more personable, modest, kind and generous professional.

Dr. Moses is double boarded in neuropsychology, and is also boarded in Clinical Psychology. He is perhaps best known to many for his work at the Palo Alto V.A. in California, where he has worked since the mid 1970s as Staff and Diagnostic Neuropsychologist, Coordinator of the Psychological Assessment Unit and as Research Neuropsychologist. He has served as Professor at Stanford University School of Medicine and as Professor of Clinical Psychology at Palo Alto University. He has served as a research consultant in the U.S., China, India and South Africa, while working with multiple California state agencies. Dr. Moses' published credits include: 127 articles, 28 book chapters, 42 abstracts and about 205 book reviews and replies. In recent years, he devotes his research talents to his students and their post doc work.

Distinguished Service to Neuropsychology Awards (Leadership, Training, Practice Innovations and International Relations)

Darlyne Nemeth, PhD, M.P., M.P.A. P.

Dr. Nemeth has been a pioneer in the area of Clinical Neuropsychology for over 30 years and was the first in Louisiana to establish a private practice Neuropsychology Laboratory in 1977. She also established the first Neuropsychology Laboratory at the Louisiana State University Student Mental Health Service in Baton Rouge. After serving as Vice-Chair of the Louisiana State Board of Examiners of Psychologists (LSBEP), Dr. Nemeth was instrumental in the movement to have Clinical Neuropsychology recognized as a specialty area in the State of Louisiana.

Dr. Nemeth was affiliated with the Department of Psychology at Southeastern Louisiana

University (SLU), where she taught Cognitive Neuroscience and Functional Neuroanatomy (Spring 1999). Dr. Nemeth taught Introduction to Psychology at Our Lady of the Lake College (Fall 2007 – Spring 2009). She served as the Director of Neuropsychology at Sage Neurorehabilitation Hospital Outpatient Services for 5 years.

Dr. Nemeth is currently serving as Co-Secretary General for the World Council for Psychotherapy (WCP) and has been a WCP/DPI/NGO Delegate to the United Nations. Dr. Nemeth has been nationally and internationally recognized for her Hurricane Anniversary Wellness Workshops, which, in cooperation with many government, religious, and professional organizations, were offered to the victims/survivors of Hurricanes Katrina and Rita in the Summer 2006 and was offered in August, 2015 for the 10th Anniversary of Hurricane Katrina.

Dr. Nemeth recently hosted an International meeting in Moscow that described the contributions of Luria and Reitan to child Neuropsychology.

Patricia Pimental, PsyD, ABN

Dr. Pimental is President and CEO of Neurobehavioral Medicine Consultants, Ltd. She is currently Adjunct Associate Professor at Midwestern University, College of Health Sciences, Department of Behavioral Medicine. She was previously the Director of the Neurobehavioral Medicine Program at Glen Oaks Hospital and Director of Psychological and Neuropsychological Services in the Department of Physical Medicine and Rehabilitation at the University of Illinois College of Medicine at Chicago. She is senior author of the textbook Neuropsychological Aspects of Right Brain Injury and the book-test instrument combination, "The Mini-Inventory of Right Brain Injury (MIRBI) and the MIRBI-2 (2000)." She is also published in national and international journals.

Dr. Pimental is a Past President of the Illinois Psychological Association and has served on several committees of the American Psychological Association. She is the 1993 recipient of the "Outstanding Paper of the Year" award from the American Journal of Pain Management. She is board certified by the American Board of Professional Neuropsychology (ABN) and a board examiner for the ABN as well as being elected to numerous board offices including President. She is now a Past-President of the American Board of Professional Neuropsychology (ABN).

Dr. Pimental is a Fellow of the National Academy of Neuropsychology, the Illinois Psychological Association and the American College of Professional Neuropsychology. Dr. Pimental has done pro bono work with the American Red Cross and has served as a volunteer member of the disaster mental health services program.

Robert A. Leark, PhD, ABPdN

Dr. Leark received his doctoral degree in clinical psychology from United States International University (San Diego, now Alliant International University) in 1982. He then completed a post-doctoral fellowship in clinical neuropsychology at the University of Nebraska, College of Medicine.

He has maintained research in clinical care of individuals with neurofibromatosis, type 1 (NF1); specifically investigating the relationship of attention and concentrations deficits in NF1. He has published research towards the use of ADHD medications within NF1, pediatrics through adults.

In addition, he has published on test and scale development, he is developing and co-authoring the Pediatric Performance Validity Test Suite (PdPVTs), an instrument designed to measure effort within pediatric psychological & neuropsychological testing.

He is Professor (Emeritus) of Forensic Psychology at Alliant International University, San Diego.

Barry M. Crown, PhD, ABN

Dr. Barry Crown is past president of the American Board of Professional Neuropsychology. During his presidential term, the American College of Professional Neuropsychology (ACPN) held an annual multi day CE conference.

Dr. Crown has served previous academic appointments with Boston University, University of Illinois School of Medicine, University of Miami School of Medicine, Florida International University, Florida State University College of Medicine. He has worked as the Research Coordinator for the Governor's Office, State of Florida; Clinical Director NIMH National Drug Abuse Training Center; Associate Director, National Council on Drug Abuse; Co-Director, Child Abuse Project, University of Miami School of Medicine; Scientific Advisor to the Director, National Institutes of Health (Additions), just to name a few. He is the current Dean, Continuing Medical Education, Clinical Education Coordinator and Director, Continuing Psychological Education, Baptist Health, Miami, Florida.

Dr. Crown presented the first studies of the use of brain SPECT to detect malingering. He is currently researching the use of Omni DTI and resting fMRI to look at the neuropsychology of violence and risk taking.

No Surprises Act brings new billing disclosure requirements

As licensed providers, psychologists must now provide estimated costs of services.

The No Surprises Act went into effect at the beginning of the year. Psychologists and other health care providers are now required by law to give uninsured and self-pay patients a good faith estimate of costs for services that they offer, when scheduling care, when the patient requests an estimate, and when there are changes in estimated costs.

The No Surprises Act aims to reduce the likelihood that patients may receive a “surprise” medical bill by requiring that providers inform patients of an expected charge for a service before the service is provided. The government will also soon issue regulations requiring psychologists to give good faith estimates to commercial or government insurers, when the patient has insurance and plans to use it.

Psychologists and other providers must provide all uninsured and self-pay patients a good faith estimate of expected charges that is available in a written document that is clear, understandable, and prominently displayed, stated orally when the service is scheduled or when the patient asks about costs, and is available in accessible formats and language(s) spoken by the patient. The estimate must be provided within specified timeframes. If any information provided in the estimate changes, a new good faith estimate must be provided.

Psychologists working in group practices or larger organizational settings and facilities will likely receive direction from their compliance department or lawyers. Psychologists in independent and small practices are encouraged to learn more about how to be compliant with the No Surprises Act. 


Update on Houston Conference

The Houston conference 2 working committees had been very busy this last quarter. The planning for the conference has been underway, we are now working out details such as alternatives should there be need to not be able to meet face to face, such as if we have another COVID out break and so forth. The major neuropsychological organizations including ABN, have donated money and at this point we have nearly half of what we need to do the conference. The Finance Committee is working on methods for others to be able to donate to cover the costs of this conference. If you would like to donate to help cover the costs of this conference, the donation will be tax deductible and there will be a letter sent out soon to give details of how you can donate. The Finance Committee is also contacting other neuropsychological organizations and test companies to see if they would like to cover some of the costs.
