



Election Results and New Positions



Member-at-Large —Bradley Sewick




Dr. Bradley Sewick is a graduate of the University of Michigan and University of Detroit and completed internship and residency training at Sinai Hospital of Detroit. He then completed postdoctoral training with a clinical professor of neurology at New York University School of Medicine. He served as a clinical professor of psychology and has affiliations with hospitals and university training programs. His affiliations include the University of Michigan, Michigan State University, Oakland University, Detroit Medical Center, University of Detroit-Mercy and Michigan School of Psychology. He teaches physicians in resident training in Psychiatry at Wayne State University

School of Medicine. Dr. Sewick was president of the American Board of Professional Neuropsychology (ABN). He sits on the ethics committee for the Michigan Psychological Association (MPA). He was Chair of the Work Sample Examination Committee of ABN for 10 years. He has been a member of the Insurance Committee and Continuing Education Committee for the MPA and has provided testimony on behalf of MPA to the Michigan House of Representatives opposing proposed legislation that would have limited practice and access for psychological services. He has published research in the area of brain trauma in peer reviewed medical and professional journals.

Quality and Assurance Coordinator — Carlton Gass

Dr. Gass earned his bachelor's degree at Vanderbilt University (1977), a M.A. in Education at Princeton Theological Seminary (1979), and a Ph.D. in Clinical Psychology at the University of Louisville (1985). He completed a neuropsychology internship at the Miami VA Medical Center (1984) and a traineeship in the Department of Neurology at the



University of Miami School of Medicine (1985). He served as the Director of the Neuropsychology Division at the Miami VA for 27 years and supervised over 200 doctoral students, designed numerous assessment software programs, and completed many research projects and publications in the areas of neuropsychological and personality assessment. Dr. Gass continues editorial work with several journals and as an ad-hoc reviewer for numerous journals including The Clinical Neuropsychologist and Applied Neuropsychology: Adult. In addition to his board certification with ABN, he is a Fellow of the National Academy of Neuropsychology, received board certification by the

American Board of Clinical Psychology (ABPP-CP), and was a charter diplomate for the American Board of Assessment Psychology.

Academy of the American Board of Professional Neuropsychology (AABN)

AABN made some needed changes over the past year, and it is hoped that the fruits of our labors will begin to pay off in 2023. AABN is currently in the process of updating our consortium affiliation manual to note some changes in practice which have been implemented in 2022. After receiving favorable feedback from the DOTs, on 7/11/2022 the ABN Board approved that AABN site dues/renewals and certificates will be processed every two years. Dues will be collected from sites during even numbered years. While the renewal dues and the site certificates will be effective for two years (e.g., 2023 through 2024), each site is required to submit an annual Attestation Checklist and Notification form at the end of the post-doctoral year (between June and August of each year). These forms will be available on the AABN website (AABNonline.com) and can be returned to AABN Chair either via email or postal mail.

Another initiative is the promotion of postdoctoral fellows to take the written exam for ABN board certification during the last three months of the fellowship. Regardless of whether the postdoctoral fellow passes the exam or not (they have up to three attempts), this qualifies the postdoctoral fellow to complete the entire board certification process free of charge, provided it is completed with the two years following the fellowship.

In addition, AABN is preparing to implement weekly formal didactic experiences for the postdoctoral fellows through the resources of our consortium affiliates starting in January 2023. AABN will provide the Zoom platform. The trainings can be provided by the DOT or supervisor, post docs, or affiliated professionals at the assigned site. The site DOT will decide upon the appropriateness of the topic, though it must be relevant to the field of neuropsychology.

AABN is also collaborating with the American College of Professional Neuropsychology (ACPN) to bring additional outside trainers to offer presentations which are available for view by AABN post-doctoral fellows, as well as site Directors of Training and Supervisors for CEUs free of charge. We plan to record all of these trainings and then upload them to the video bank on the AABN website for later viewing.

AABN currently has 10 active sites, recently approved another site, and has others actively pursuing affiliation. I would like to thank our site DOTs and supervisors for all of your hard work throughout the year. Our goal in AABN is to continue offering supports to AABN sites so you can focus your attention upon promoting excellence in the training of tomorrow's neuropsychologists.

American Board of Professional Neuropsychology (ABN) Awards for 2022

Distinguished Neuropsychologist Lifetime Achievement Award (Research, Leadership, Training and Practice)

Robert Heaton, PhD, ABPP (CN)

Dr. Heaton received his B.S. in International Affairs from the U.S. Air Force Academy and his Ph.D. in Clinical Psychology from the University of Washington. He was Assistant and then Associate Professor of Psychiatry at the University of Colorado School of Medicine from 1973 to 1987. In 1987 he became the UCSD Director of the SDSU/UCSD Joint Doctoral Program in Clinical Psychology, which recently has been ranked the #1 Clinical Psychology program in the U.S. by The Chronicle of Higher Education. Since 2005 he has been the Vice Chair for Academic Affairs for the Department.

Dr. Heaton's research focuses on three areas: effects of HIV and comorbid conditions (methamphetamine use disorders, Hepatitis C co-infection) on the brain and behavior; psychometric issues in neuropsychology (cross cultural neuropsychology, demographic influences on test performance, developing demographically corrected test norms for accurate detection and characterization of CNS disorders, longitudinal measurement of treatment outcome and disease progression); and schizophrenia (detection of prodromal phase, effects of cognitive impairment on everyday functioning, and measuring outcomes of treatments aimed at such effects.



Distinguished ABN Scientist and Outstanding Continued Contributions to Neuropsychology

John Meyers, PsyD, ABN, ABPdN

Dr. John E. Meyers is well known to the American Board of Professional Neuropsychology (ABN). During his career he has contributed much to the field of neuropsychology. To highlight just a few, Dr. Meyers has been a member of ABN since 1996, holding diplomate #295. He is also board certified with the American Board of Pediatric Neuropsychology since 2006 obtaining diplomate #2057. He obtained his doctorate at the Oregon Graduate School of Professional Psychology, with his undergraduate and master's degree coming from Brigham Young University.

He has many years of service with both ABN and NAN. He served as the treasurer of ABN as well as the treasurer of the National Academy of Neuropsychology (NAN). He has been a board member of ABN as well as a board member of NAN, and was president of the board of ABN (2012-14) and the president of NAN (2017). He serves as a peer reviewer for Applied Neuropsychology, both adult and child, and as a reviewer for Archives of Clinical Neuropsychology. He has also served on various committees and functions while on the ABN and the NAN boards, including finances, serving as a reviewer for board certification and helping to write many of the procedures used by ABN and NAN.

Dr. Meyers had a varied career, working in both private practice and hospital practice since 1991, in rural and urban settings. His background is in rehabilitation and in neuropsychological assessment. He also served with the Department of Defense working with brain injured service members and then overseeing the worldwide testing program the military uses for redeploying service members.

Dr. Meyers has published more than 60 peer reviewed articles and is the author of the Meyers Neuropsychological Battery (MNB) which is a well-known core battery of common neuropsychological tests with the ability to use statistical analysis to help the clinician be more accurate and consistent. He and his lovely wife Kelly are the authors of the Rey Complex Figure and Recognition Trial that we all know and love.

Dr. Meyers has also agreed to be our representative on the Inter-Organizational Practice Committee (IOPC), so even though he has "retired" after 30 years of clinical work, he is still much involved in the field of neuropsychology.

Distinguished Service to Neuropsychology Award -Leadership, Training, Peer Support and Practice Innovations

Dan DaSilva, PhD

Dr. DaSilva is a neuropsychologist with Morris Psychological Group in Parsippany, New Jersey. He specializes in aviation and pediatric neuropsychology. Dr. DaSilva earned his doctoral degree from Farleigh Dickinson University, a masters of education in from the University of Mass at Boston, and bachelor's degree in psychology from Boston College. He completed specialized neuropsychology training through the Veteran's Administration in a consortium with UMDNJ and Univ Hospital in Newark, New Jersey.

Dr. DaSilva devotes a significant portion of his practice to neuropsychological and psychological assessments of pilots, both experienced pilots and new applicants, also air traffic controllers. He serves as a neuropsychology consultant to the Federal Air Surgeon of the Federal Aviation Administration and is an external consultant for several major airlines. He has presented at national and international conferences and symposia on the subject of aviation neuropsychology and has been accepted by the National

Transportation Safety Board provide expert testimony in aviation neuropsychology at NTSB hearings.

Dr. DaSilva is also a neuropsychological consultant to the pediatric neuro-oncology and pediatric seizure disorder programs at Morristown Medical Center and at Overlook Medical Center in Atlantic Healthcare's Neurosciences Institute. Stephen Kalat, Ph.D. is a licensed psychologist with over forty years' experience. He is a graduate of The American University, Washington, D.C., 1977, Dr. Kalat completed his internship at Denver General Hospital in 1978. He received neuropsychological training through continuing education programs of the University of Denver, National Academy of Neuropsychology, American College of Professional Neuropsychology, Reitan Neuropsychological Laboratory, American Psychological Association, and the Albert Einstein College of Medicine, as well as two years of post-doctoral supervision in Clinical Neuropsychology. He has practiced in the field of neuropsychology since 1993.

Dr. Kalat has served as President of the Colorado Neuropsychological Society; on the Board of Directors of the Brain Injury Association of Colorado; as Director of Psychology for two Denver-area hospitals.

While in graduate school, Dr. Kalat helped organize mental health services at the Washington Free Clinic in Washington, D.C. and served as the Vice President of its Board of Directors. He was given an award for Distinguished Service to Psychology by the Colorado Psychological Association in 1993. He was awarded status as a Fellow of the National Academy of Neuropsychology in 2015.

We wish to recognize Dr. Kalat for his outstanding contributions to the field of neuropsychology, dedication to promoting excellence and ethical practice and his contributions and support to fellow neuropsychologists. Many practitioners are aware of his keen knowledge of the literature and his willingness to assist fellow neuropsychologists. We commend his dedication to and promotion of the field of neuropsychology and his outstanding examples of peer support.



Alan Breen, PhD, ABN

Dr. Breen earned a Ph.D. from the University of Washington in 1982. He completed his predoctoral internship at Topeka State Hospital and postdoctoral fellowship through the University of Washington. He achieved Board Certification with the ABN in 1999. Before entering private practice, he was head of outpatient services with a community mental health center and chief neuropsychologist at a post-acute residential rehabilitation center for people with moderate to severe brain trauma. His private practice interests have included neuropsychological assessments for injured and disabled workers, learning disabled adults, and for individuals with neurocognitive and neurobehavioral disorders. He has been an active participant in aviation psychology for more than 15 years.

His forensic practice includes civil and criminal work. He has utilized neuropsychological and developmental psychology assessments to help attorneys navigate recent changes in Federal and State guidelines that allow a defendant's 'youthfulness' to be considered, as well as contributing to appeals for reduced sentences for teenage defendants serving life providing hope for people who have literally grown up in a state penitentiary. He is past President and current Board member of the Pacific Northwest Neuropsychological Society.

Distinguished Service to ABN Award

Leadership and Practice

Thomas Bristow, PsyD, ABN

Initially educated and trained in the field of clinical psychology, Dr. Bristow interned at the student counseling center of the University of Virginia. Dr. Bristow's interest in neuropsychology began during his internship that provided a 15-week rotation at a psychiatric hospital administering supervised neuropsychological evaluations. He furthered his education by obtaining an advanced certificate in clinical neuropsychology from the Fielding Institute and became board certified by ABN in 2008. Since 1990 Dr. Bristow has worked in private practice, psychiatric hospitals, school districts and a correctional facility.

In 2012, Dr. Bristow was appointed to join the board of ABN as an assistant to the president. The following year Dr. Bristow was appointed as treasurer of ABN and served as the treasure for two terms. He is currently the President of ABN. As a tenured and full professor, Dr. Bristow was chair of the psychology department at Lewis University in Romeoville, Illinois from 2015 to 2020. Currently, he is the Associate Dean of the College of Education and Social Sciences for Lewis University.



Wendy Marlowe, PhD, ABPP, ABN

Wendy Marlowe, Ph.D. ABPP, has been practicing clinical neuropsychology for over 45 years, the last 35+ which have been in Seattle, Washington. She is licensed in the State of Washington, board certified as a Diplomate in Neuropsychology, granted by the American Board of Professional Psychology, and a Fellow in the National Academy of Neuropsychology. Her primary professional activities involve independent practice and clinical research.

Dr. Marlowe has been active in issues involving diversity and equity throughout most of her personal (March on Washington, 1963), and professional life. She was instrumental in the establishment of a women's restroom at the computer center at Northwestern U (1965), and was the first woman and non neurologist inducted into the Philadelphia Neurological Society (1969). She began giving presentations and papers on culture and diversity in 1992 and has remained active in issues related to culture, diversity and equity as they relate to psychology, neuropsychology and the community at large.


Dr. Marlowe is an active member of the professional neuropsychological community. She has published in The Clinical Neuropsychologist, Journal of Clinical and Experimental Neuropsychology, Brain and Cognition, Developmental Neuropsychology and Pediatric Rehabilitation. She has presented at the International Neuropsychological Society, American Psychological Association, Washington State Psychological Association, The World Congress of Neuro Rehabilitation and numerous other venues.

Dr. Marlowe has served the APA as a member of the Committee on Disability Issues in Psychology, as a Consultant in Adolescent Health, and as a member of the Council of Advisors for the APA Project on Adolescent Health. She has been a member of the Minority/Ethnic Affairs Committee of Division 40 and a past president of the Pacific Northwest Neuropsychological Society.




Eric Freitag, PhD.

Update on TPO and Release of Information

Geoffrey Kanter, PhD, ABN, ABPdN had an initial meeting with reps from AACN, SCN, CNC, and NAN about the issue of TPO and Release of Information challenges that each organization is getting involved with in terms of supporting their membership with Amicus Briefs and support to attorneys who are fighting these battles with us in various states. Rather than deal with this on an organization by organization basis, the idea was to join forces and share in the knowledge and support and expenses together, as these issues appear to be increasing in frequency. Such cases include the case ABN wrote and Amicus Brief for in Nevada, the Michigan Amicus Brief AACN was involved with, and the very recent CA case that all organizations were involved as signatories to the IOPC Letter of Support for the AACN Letter to the appellate court describing the problematic issues with the judge's decision to allow TPO AND provide raw data and test manuals to various individuals who are not licensed psychologists.

Here is a summary of the (complicated and many faceted) conversation: ☐ The organizations represented on the call agree that TPO and test security issues are increasing concerns in the forensic arena. ☐ The biggest player in psychology, APA, is also interested but processes in APA move slowly. APA hasn't sponsored a relevant amicus brief in a very long time (perhaps 1977?). ☐ The IOPC does seem like a good place to work together on these topics, but as leadership we wanted to use top-level discussions to help set a framework and agenda. ☐ Options for initiative/project funding were discussed, but at this point funding remains with each organization. ☐ Multiple perspectives need to be considered. We're not yet ready to invite non-NP to the table, but success will likely require consideration of these perspectives: o NP experts in civil cases o NP experts in criminal cases o Forensic psychologists outside of NP o Cross-specialty psychology organizations (e.g., APA, State Psychological Orgs) o Test publishers o Attorneys wanting to find good NP experts o Public

o State Legislators

Some challenges were highlighted in different spheres: ☐ Neuropsychology: Many practitioners find themselves in forensic settings with inadequate preparation. There is a lack of knowledge-sharing. There are times when even well-prepared and knowledgeable NPs need organizational backing via amicus briefs ☐ Public sphere: Public does not understand neuropsychology or the testing enterprise, nor concerns around test security and TPO. ☐ Lawyer sphere: Although there are lawyers trying to simply exclude qualified neuropsychologists, some others simply don't know how to distinguish qualified NPs from lousy/unqualified "experts" ☐ Commercial/industry sphere: Test publishers historically not involved case-by-case in issues of test security ☐ Cross-specialty organization sphere: barriers to action (e.g., relevant APA amicus briefs in modern era) are unclear, lack of partnership with other specialties to find common ground, lack of inroads in cross-specialty organizations ☐ Legislative sphere: Case precedent is much weaker than actual statutes, and right now we seem to be playing case-by-case "whack-a-mole."
