WHY VOTING MATTERS

The right to vote is one of the most important, yet basic rights of the American people. In our democratic government, every person is considered equal and is empowered to use their voice to impact issues on local, state, and federal levels of government.

Citizens over the age of 18 cannot be denied the right to vote on the basis of race, religion, sex, disability, or sexual orientation. In Indiana, citizens must register to vote.

Through our votes, we're able to express our values and make our voices heard on the key issues that affect our lives, businesses, and communities at large, issues like healthcare, taxes, education, and so much more.

YOU HAVE THE RIGHT TO VOTE:

- In a free and fair election
- Privately and independently, in a voting booth that is free from any unauthorized materials
- In an Indiana election, if:
 - You are a U.S. citizen, AND
 - You are a resident of Indiana, AND
 - You will be at least 18 years of age at the next Primary Election, May 5, 2026, AND
 - You are not currently in prison after being convicted of a crime,
 - You have lived in the precinct where you vote for at least 30 days before the election, AND
 - You are registered to vote.
