# MEMBERSHIP

## Categories & Levels Defined

**Non-Profit Organization:** Intended for non-business entities offering charitable services which are not conducted primarily to make a profit and/or are not receiving payment in return.

**Business Builder:** Intended for sole proprietors who want to partner with the Chamber to bring awareness to their business. Membership at this level is offered for the first year of membership only.

**10 or less employees:** Intended for small businesses who want to partner with the Chamber to bring awareness to their business and have access to build their circle of influence within the Chamber and the community.

**11-30 employees:** Intended for businesses and for-profit organizations with 11-30 full-time employees or equivalents.

**31-50 employees:** Intended for businesses and for-profit organizations with 31-50 full-time employees or equivalents.

**51-99 employees:** Intended for businesses and for-profit organizations with 51-99 full-time employees or equivalents.

**100+ employees:** Intended for businesses and for-profit organizations with 100+ full-time employees or equivalents.

**Individual Members:** Intended for community members and individuals wishing to have access to build their circle of influence within the Chamber and the community. Listing will not include employer name, and this membership level does not include advertising benefits.

**Associate Members:** Intended for sister- or child-companies of current members. Also includes individuals who wish to expand their professional work and impact.

**Education:** Intended for primary, secondary, and higher education organizations. This should supersede employee-based membership investment levels for educational organizations.

**Incorporated Towns:** Intended for municipal corporations.

**Financial Institutions:** Intended for banks, credit unions, and the like.

**Financial Institution Associate:** Intended for secondary location(s) of primary financial institutions.
