



## **Bay Of Quinte Golf & Country Club 2024 General Terms & Conditions**

Guests of the Bay of Quinte Golf and Country Club agree to abide by the terms and conditions set out below.

### **General Terms:**

- 2024 Golf passes are effective from time of purchase to December 1, 2024.
- A tee time whether booked for 9 or 18 holes counts as a round.
- All golfers are responsible for any damage they cause to the BQGCC and its property.
- The course may be closed periodically throughout the season for course maintenance and special events.
- Daily tee times will finish at 6:00 pm and may vary throughout the season.
- Valid proof of age is required for intermediate players.
- Guests must abide by BQGCC rules and regulations and respect the rights of other guests and staff. Failure to do so will result in privileges being suspended. Suspended package holders are not entitled to any refund.
- The club reserves the right to terminate package holders without cause and issue prorated refunds.
- Credit card purchases are subject to a 2% surcharge

### **Cancellation Policy:**

A reservation may be canceled up to 24 hours in advance of the tee time either through the website or by contacting the pro shop. The pro shop must be contacted in order to cancel a reservation within 24 hours of play. Any cancellation made less than 24 hours prior to play will be charged the full green fee. If the pro shop is closed, please leave a detailed message stating your cancellation request. If your tee time is subsequently filled, a cancellation fee will not be charged. As an alternative, players needing to cancel under the 24 hour notice period are welcome to find a substitute player to take their time to avoid a cancellation fee.



### **Rain Check Policy:**

Rain Checks will be issued under the following conditions:

- Where significant rainfall or lighting conditions has persisted for a minimum of 30 minutes (no earlier). Pro shop staff will record the time that rain begins and rain checks will be issued no sooner than 30 minutes after such time.
- Drizzle or light rain is not considered in the guideline.
- If a player should choose to tee off in the rain there will be no rain check given.
- Rain check vouchers are prorated based on the number of holes played and can be used towards future rounds.
- For passholders If you tee off when it is not raining and significant rainfall occurs your pass will be unapplied if you played 5 holes or less. If rain prevents you from playing past the 14th hole you will receive a 9 hole pass. If you start the 15th hole then there will be no rainchecks offered.
- Rain checks will not be issued simply because a player has become wet because of lack of rain protection gear.
- Rain checks cover green fees and power carts.
- Players will not be charged a cancellation fee if their round is canceled due to rainfall at the course. They must contact the pro shop if they are uncertain about the weather conditions at the course.
- If the club deems that play must be suspended due to weather conditions passes will not be redeemed if 9 or fewer holes have been played.

### **Dress Code:**

The Bay of Quinte Golf and Country Club has a dress code for all participants. We require appropriate golf attire. For men: golf shorts or golf pants, no graphic tee shirts. For Women golf shirts (if sleeveless it requires a collar), golf shorts, skorts, or pants.

- The Bay of Quinte Golf and Country Club is also a “soft spike only” facility - no metal spikes allowed.



**Club Etiquette:**

- Consideration and courtesy of fellow guests and employees of the Club is expected at all times.
- Proper attire is required.
- Foul language and abusive behavior will not be tolerated.
- Smoking is not permitted within 5 meters of the clubhouse, pro shop or other structures at the Club.
- Pace of play is rated at 4 hours and 20 minutes for an 18 hole round by Golf Ontario.
- All golfers will check in at the pro shop and with the starter before teeing off. **Failure to check in prior to play will result in the immediate suspension.**
- All members and guests will obey the laws of Ontario, including the Liquor License Act, while at the Club. The Liquor License Act forbids bringing outside alcohol to the Club. **There will be no exception to this policy and playing privileges will automatically be suspended without refund for violations. Additional information about the Liquor License Act can be found at the Club office.**

I/We acknowledge reading and understanding the General Terms and Conditions and further acknowledge that the Bay of Quinte Golf and Country Club may suspend or terminate a member for failing to abide by these Terms & Conditions.
