Recreational Vehicle Parking Requirements



As summer is upon us and camping season is in full swing, the Village of Minster Zoning Board would like to remind residents about the zoning requirements for recreational vehicles. The off-street parking of recreational vehicles, boats, campers, travel trailers, and utility trailers are permitted in front yards for loading and unloading purposes if they are parked there for no more than 24 hours.

All recreation vehicles shall be kept in good repair and where applicable, carry a current year's license plate and registration. Such trailers are also permitted to be parked long term in rear yards or behind the building setback lines in side yards if the trailer is no longer than 30 feet.

No more than one recreational vehicle shall be permitted to be stored outside on a parcel.

Finally, no such recreational vehicle shall have permanent connections to utilities, nor shall such equipment be used as a dwelling.

Tree Limb Pickup Reminder

Curbside branch pickup continues Monday's, weather permitting. Branches (5 inches in diameter or smaller) may be placed between the sidewalk and curb or by the alley. We do not have the capabilities with the equipment used for branch pickup to pick up grass. All grass clippings and other yard waste can be brought to the Village Yard Waste Transfer Facility. All yard waste must be deposited on the appropriate pile, no co-mingling.



Fireworks Ordinance



The Village Council has a Fireworks Ordinance in accordance with Ohio law (ORC 3743.45 and 5626) following past incidents involving unsafe fireworks use within village limits. The ordinance allows the Minster Police Department to act when fireworks are used irresponsibly or dangerously, including directing individuals to stop use, issuing citations, and confiscating fireworks when necessary. The Village's goal is to promote public safety while still allowing residents to responsibly enjoy firework celebrations.
