<u>Fees:</u> Non funded fees are calculated at a fixed 12 monthly rate based upon the total price of your child's normal weekly sessions. We calculate your monthly fees using the formula: cost of daily rate x 52 weeks divided by 12 months = fixed monthly amount. Non funded fees are inclusive of nappies, wipes, sun cream, meals, snacks, drinks, and extra-curricular activities.

<u>Minimum Booking:</u> Sessions should fit into the session times detailed on the fees structure; however, we will attempt to meet individual needs where possible. Depending on availability preference will be given to families also booking full time places. A minimum of 3 sessions, spread over 3 days, must be booked to commence at the nursery, at least one of these must be a Monday or a Friday.

<u>Funding</u>: Children over the age of 3 are entitled to 15 hours per week of funded sessions from the term after their third birthday. This entitlement is term time only, so we stretch the entitlement over 51 weeks, making it 11 hours per week. We also offer 30 hours funding for children over 3 years old. We offer this funding stretched to 22 hours per week. For funded sessions, we charge £1.25 per hour for the provision of meals, snacks, nappies, drinks, sun cream and resources. This is itemised as meals and consumables on your invoice. From April 2024 for eligible families we offer 2-year-old funding, also stretched to 11 hours a week. From September 2024 for eligible families, we will be offering 15 hours funding stretched to 11 hours a week funding from the age of 9 months.

<u>Booking Patterns:</u> To increase your booking pattern, we require 24 hours' notice, subject to availability. To decrease your booking pattern, you must provide us with 30 days' notice by email to the nursery manager. We require 24hrs notice of any cancellation of booked additional sessions otherwise the session will be charged. <u>Payment of fees:</u> Each month you will receive a monthly invoice. Payment of fees are payable in advance by direct debit, childcare vouchers, or Tax-Free Childcare within the first 10 working days of each month. Late fees apply for late payment. Please see terms and conditions.

<u>Missed sessions</u>: No refunds or additional sessions will be given for sessions missed due to holidays, sickness, isolation, Bank Holidays, Christmas closure or for the closure of the nursery due to circumstances beyond our control.
