director's report

Dear Friends,

If you haven't visited athensfoundation.org recently, I invite you to do so – you'll see our updated website with our new look, our new logo, and easy navigation where you can find how to get involved. You'll also see words like collaborate, community, connect, and co-create. Co-creation was a big theme of 2024 at the Athens County Foundation.

Housing Security Co-Create Group

ACF plays a vital role in the Housing Security Co-Create effort as a convener, funder, and advocate for inclusive, community-driven solutions. Beginning in January 2024, ACF brought together more than 40 community organizations for ongoing meetings and collaborative work to address immediate and long-term needs for housing security in Athens County. Highlights include:

- Helping Hocking Athens Perry Community Action (HAPCAP) secure funding to purchase and rehabilitate the former Sunset Motel into a low-barrier shelter for individuals and families experiencing housing instability.

- Supporting an emergency motel voucher program, led by My Sister's Place.
- Launching an emergency warming center at the old fire station on Columbus Road, led by The Gathering Place and the City of Athens.
- Improving information about available housing and daily living resources, and educating the public about housing insecurity. This included a Grover Lecture featuring Matthew Desmond, author of "Evicted" and "Poverty, by America."
- Establishing the Housing Security Fund, which has already awarded more than \$16,000 to direct service providers.

New Funds

In addition to the Housing Security Fund, other new funds opened as of 2024 include the Athens City School District Support Fund, the Racial Equity Coalition of Appalachia Fund, the Dairy Barn Laufman Sub Fund for Education, the Susan B. Anthony Memorial Unrest Home Fund,

the Disc Golf Fund, the Redbud Fund (see page 8), and the Leadership Athens County Youth Support Fund. The total number of open funds administered by ACF is now 77.

Leadership Athens County

2024 was the inaugural year for Leadership Athens County Youth. Seventeen students from high schools around Athens County completed the place-based and asset-focused program intended to develop a corps of informed leaders now and in the future. The flagship Leadership Athens County program continued for its 19th year. Fifteen local leaders – including myself – participated, bringing the total of LAC graduates to nearly 400! LAC gave me a deeper appreciation for our community and a renewed sense of pride in supporting the work that makes this program possible.

Grantmaking

Along with our longstanding partners, the Osteopathic Heritage Foundation of Nelsonville, the Sisters Health Foundation, and the Rocky Community Improvement Fund as well as our donor-advised funds, we awarded \$811,108.57 to 211 community organizations. We launched our Flexible Microgrants (up to \$3,000) Program, an evolution of our previous Covid-era Response and Capacity Building Grants.

We appreciate each and every one of you who has supported us through your work with Co-Create, your financial contributions, and your participation in Leadership Athens County. We believe everyone has a part to play and that when we come together, we can effectively co-create our shared future.


TURNING RETIREMENT ACCOUNTS INTO CHARITABLE GOOD

If you are in your 70s and receiving minimum IRA distributions but do not need the extra income, you can make a significant lifetime gift that positively impacts the community!

It is possible to give individual retirement account (IRA) retired distributions to a charity, free from federal tax, annually.

Using IRA assets to make a gift during your lifetime, as opposed to giving via a bequest in your will, enables you to experience the joy of making a major gift.





NEW FUNDS

rebdud fund

A new donor-advised fund created through the Athens County Foundation will support environmental resiliency, local economies, community wellness, and a diverse and equitable Athens County. “Investing locally with the Athens County Foundation means we’re really investing in people’s ideas. There is just an amazing synergy of creative ideas and people with visions,” says Katy Kropf, who along with her partner Nick Tepe, created the Redbud Fund in 2024.

Kropf earned her medical degree at Ohio University’s Heritage College of Osteopathic Medicine in 1998, then returned to Athens in 2008. She is now an assistant clinical professor at OU-HCOM. Tepe has been director of Athens County Public Libraries since 2016.

“For me, throwing myself into the community is what I do as a librarian,” Tepe says, “I came to know and love everything about Athens.” So when Kropf inherited securities from her grandparents, she and Tepe knew they wanted to make a difference with this gift. Tepe adds, “Athens County Foundation does essential work for our community, whether it’s the Housing Co-Create group, or Leadership Athens County, or the general support of other local nonprofits.”

Since the resource at hand was in the form of stocks and bonds, selling them would have incurred capital gains. If the couple had decided to manage the funds themselves to donate to local nonprofits directly, that would have amounted to a lot of hands-on work. The perfect solution was to donate the securities to ACF through a donor-advised fund.

“When ACF manages the donor-advised fund, they get the management fees for it – instead of the fees going to brokers,” Tepe says, “Even the fees are put to good use. That’s super important to me.”

As for the name Redbud? Tepe advocated for the name. “Redbuds are absolutely my favorite thing about the Appalachian foothills,” he says. “It’s the spark that sets out the bloom throughout the forest. It’s a sign of hope, it’s a sign of renewal, and it’s unique to this area. I like the resiliency of the tree as well.”

To that end, the Redbud Fund supports environmental projects and economic development projects that counter the historic extractive industries in the county, like mining and logging. A third pillar that supports LGBTQ+, racial equity, and health and wellness projects is informed by Kropf’s work in family medicine over the past 14 years. “Helping to ensure equity of access for historically marginalized and disadvantaged groups is central to my work as a physician and our desire to build a healthy community,” Kropf

says. "It feels good to be a part of trying to bring people up, trying to be part of the solution. There's a lot of suffering in the world. The Redbud Fund allows us to tap into the creativity that exists in this community, to support the assets of this community."

While ACF does the legwork of awarding grants in the donor-advised areas to local nonprofits, donors like Kropf and Tepe can also proactively steer ACF toward organizations or programs that could be a good fit for the funding, provided they qualify to apply for the grants.

If there is one thing the couple wants others to know about setting up a donor-advised fund, Tepe puts it simply: "This is really easy to do. Setting up a donor-advised fund is a really good way to put that money to good work. And many thanks to the Athens County Foundation staff, they make it very easy."



investing in capacity

In 2024, ACF and our long-standing partner, Sisters Health Foundation, jointly announced \$52,000 in funding to support capacity-building efforts for nonprofits serving Athens County. Through flexible grants of up to \$3,000 per organization, we aimed to strengthen the internal operations and infrastructure that allow nonprofits to sustain and scale their impact. Applications were accepted on a rolling basis, with special attention given to smaller organizations with significant capacity needs. In total, \$55,482 was granted through this program.

BUILDING STRONGER LEADERS AND NETWORKS IN ATHENS COUNTY

ACF's support for local organizations has always extended beyond grantmaking—through facilitation, convenings, the Leadership Athens County program, and targeted capacity-building workshops. In 2024, we deepened this commitment by formally launching our monthly **Strengths + Strengths** workshop series and strengthening the monthly **Executive Directors' Lunches**, creating consistent spaces for learning, leadership development, and peer support across the sector.

STRENGTHS + STRENGTHS WORKSHOP SERIES

The **Strengths + Strengths (S+S)** series brought together 98 nonprofit professionals from 53 organizations to engage in nine interactive sessions covering topics such as strategic planning, fundraising, and leadership development. The program was designed to build knowledge and relationships among attendees.


The program also surfaced new needs such as deeper training in human resources, board development, and nonprofit finance, which will shape future offerings in 2025 and beyond.

EXECUTIVE DIRECTORS' LUNCHES

In the often-isolating role of nonprofit leadership, **ACF's Executive Directors' Lunches** provide a vital space for reflection, connection, and collaboration. Held monthly, these informal yet intentional gatherings bring together community-based organization leaders from across the county to share real-time challenges, exchange ideas, and foster a deeper sense of community and support.

These lunches are not workshops or training, they are facilitated conversations that offer nonprofit leaders a trusted space to share challenges, exchange insights, and support one another.

More than just dialogue, these conversations have sparked action—from collaborative initiatives, rethinking internal policies, or recharging one's sense of purpose. The lunches have also inspired future planning, including a nonprofit leadership retreat and a community-informed training calendar.

In 2024, these lunches tackled real-time issues like:

- Ethical staffing practices in the face of dwindling internship funding
- Organizational sunsetting and regeneration, with leaders candidly discussing when and how to gracefully close programs that have served their purpose
- Power dynamics and Diversity, Equity, Inclusion, and Justice in leadership spaces, including the role of executive presence (or absence) in fostering equitable conversations
- Multigenerational workforce management, including volunteers with varying levels of experience
- Opportunities for collaboration, such as co-programming around shared themes like food access or community wellness

strategy in action

Our work in 2024 aligns with ACF's core strategy of **Expanding Capacity**, as outlined in ACF's Strategic Framework. Whether through funding, training, or connection, our goal is to ensure that local nonprofits are not only equipped to meet today's challenges, but positioned for long-term sustainability and success.

We're proud to walk alongside these organizations as they serve, lead, and build a better Athens County for all.

project co-create

DESIGNING SOLUTIONS TOGETHER

In the spring of 2024, ACF launched **Project Co-Create**, a strategic initiative to expand participatory problem-solving across Athens County.

Importantly, co-creation is not new to this region, nor is it new to ACF. For years, the Foundation has brought people together to shape solutions, offering not just funding but one of its most powerful assets: its ability to connect. ACF's role as a convener, collaborator, and community champion has long made space for inclusive dialogue and locally rooted action.

Project Co-Create is an evolution of this work. It formalizes what ACF has always done best—hosting meaningful conversations, aligning resources, and creating opportunities for community members, especially those with lived experience, to help lead the way forward.

Through this initiative, ACF is dedicating its programs, partnerships, and investments to lift up community voice, foster collaboration, and design solutions with those closest to the issues.

Project Co-Create is our promise to Athens County. To listen deeply. To act collectively. And to keep building, together.



HOUSING SECURITY

In December 2023, a series of conversations and connections sparked collective momentum among concerned individuals and organizations. Out of that momentum, housing security emerged as a clear and urgent priority for Athens County.

Since then, monthly gatherings have created space for open dialogue, trust-building, and collaborative visioning. Each meeting centers lived experience and a shared commitment: that everyone in Athens County deserves a safe, stable place to call home.

These conversations have already ignited new collaborations and community-led ideas. Organizations are working more closely than ever. Residents with lived experience and community leaders most proximate to the housing issues, are guiding the direction of emerging efforts. Possibilities once seen as out of reach are now being explored—together.

Since December 2023, the group has:

- Formed a coalition of over 60 organizations and individuals, with active committees focused on interim solutions, best practices, education and advocacy, and fundraising.
- Submitted a grant application to renovate the Sunset Motel into an emergency shelter.
- Released the Athens County Housing Report in partnership with the OHIO Voinovich School of Leadership and Public Service.
- Launched a countywide community survey to gather input and elevate local voices.

2024 marks the beginning of this movement—one shaped by those who show up, speak out, and work together. As we continue the work of co-creation, we invite you to be part of it.

ELEVATING LEADERSHIP, STRENGTHENING COMMUNITY

Seventeen participants gathered in the Hocking Hills in September 2023 to begin Leadership Athens County (LAC) as the Flagship Class of 2024, embarking on a nine-month journey of self-discovery, community engagement, and leadership development. Through site visits, expert-led discussions, and peer-led sessions, participants explored Athens County's assets and challenges, gaining valuable insight into local issues such as economic development, housing, public health, and social equity.

This year's class embraced action-oriented leadership, driving initiatives beyond the program itself. Inspired by their experience,

graduates of the Flagship Class of 2024 established a scholarship fund to ensure that the Youth Leadership Athens County program remains accessible to all students, regardless of financial barriers.

As graduates of the 2024 program, they join a network of almost 400 LAC alumni, continuing a legacy of civic engagement and leadership that strengthens Athens County.

The impact of the program was felt deeply by participants:

leadership athens county youth

CULTIVATING THE NEXT GENERATION OF LEADERS

Leadership Athens County Youth (LACY) continued to grow in impact and participation, engaging 24 high school students from Alexander, Athens, Federal Hocking, and Nelsonville-York, including three returning from the summer workshop focus group. Over eight months, students explored topics such as mental health, democracy, and equity, while forming meaningful connections with local leaders and peers.

Despite unforeseen challenges, including the cancellation of an April session due to flooding, the cohort remained engaged, demonstrating resilience and adaptability.

With 100% of participants reporting that the program met or exceeded expectations, LACY continues to serve as a powerful platform for emerging youth leaders to develop their skills and deepen their connection to Athens County.

The program's effect on participants was profound:

"I never thought of myself as a leader before this, but now I see that leadership doesn't always mean being the loudest. It can mean listening and knowing when to step up."



CHRIS KNISELY AWARDED WOMAN OF THE YEAR

Chris Knisely was awarded Woman of the Year for her trailblazing and leadership in local politics and community engagement. Knisely retired in 2023 after serving as the first female president of Athens City Council, a position she held from 2015-2023. Prior to that she served as an at-large council member from 2008-2014. During her time on council, she worked to strengthen city and university relations and to support affordable housing and senior services. She mentored fellow council members and she was an active and visible community volunteer.

Knisely has been active with the League of Women Voters of Athens County and other local organizations. She has mentored other women in the county to become politically active and involved.



The Woman of the Year award honors outstanding women in Athens County who exhibit a courageous voice that has been – or needs to be – recognized and who make a difference to the lives of women or girls in Athens County.

The mission of the Women's Fund of the Athens County Foundation is to promote philanthropy among women and to establish a permanent fund that will provide funding to programs and projects in Athens County which empower women to achieve their full potential. Each year, the Women's Fund awards grants to Athens County nonprofits that benefit women and girls.

JEFF SWAIM AWARDED SENIOR OF THE YEAR

Jeff Swaim was recognized as Senior of the Year for his service in helping to combat financial fraud that is often targeted at senior citizens. Swaim was born and raised in Athens County and he is vice president and treasurer of Hocking Valley Bank, where he has worked for 32 years. He has been active in a wide range of bank-initiated community outreach efforts over his career.

In recent years, Swaim has been actively involved with senior and community organizations to educate seniors about identifying and responding to mail, computer and telephone fraud schemes targeting them. His local roots and family, plus knowledge of local people, places and events have fostered trust and comfort with the organizations, families and individuals he serves. Swaim often visits senior bank clients in their homes or assisted living facilities to balance check books, discuss financial strategies and to answer questions and share information.

SARAH ADKINS EARNS FOSTER B. CORNWELL AWARD

Sarah Adkins was recognized with the Foster B. Cornwell Award for her work to improve the health of those living in Athens County and southeast Ohio. Adkins is founder and executive director of Athens-based Rising Suns Pharmacy, a nonprofit pharmacy that provides free medications to people who are uninsured or underinsured. Adkins credited ACF for being the first to give financial support to the pharmacy project, which to date has served some 600 patients, dispensed 6,000 prescriptions, and saved \$2.5 million in drug costs.

Adkins is a native of Athens County, where she attended Albany Elementary and then graduated from Athens High School in 1993.
