FACILITY:	<div>Augusta Aquatic Center 3157 Damascus Road Augusta, GA 30909</div> <p>This facility’s competition pool is an 18-lane, 25-yard course, with designated warmup/ down space, separated by a bulkhead. The start ends equal a depth of 7.5 feet and turn end depth equals 7.5 feet. The competition course has been certified in accordance with 104.2.2C(4). The certification is on file with USA Swimming, Inc., and Georgia Swimming, Inc.</p> <p>Meet host will ensure the required course dimensions.</p>															
MEDICAL SUPERVISION:	The Augusta Aquatics Center has a full staff of American Red Cross certified lifeguards trained in using backboards and AEDs. American Red Cross trained Police Officer and Fire Marshall will be on hand. EMT services are available through local 911.

ELIGIBILITY:	<p>Open to all swimmers registered with Georgia Swimming who have achieved the required qualifying time standard for an event (see “Proof of Times”).</p> <p>No swimmer will be permitted to compete unless the swimmer is a member of USA Swimming as provided in <i>USA Swimming Rules and Regulations</i>, Article 302.</p>
SWIMMERS WITH A DISABILITY:	<p>Athletes with a disability are welcomed, but advance notice of desired accommodation must be provided to the Meet Referee via, the NECESSARY ACCOMODATION FORM, which should be submitted via email to the Meet Ref with your team’s entry file by the entry deadline. Failure to provide advance notice may limit the host’s ability to accommodate all requests. The Peach State Championship Time Standards will not apply to swimmers with a disability.</p>
ENTRIES:	<p>Swimmers participating in the Peach State Championships must have achieved a Peach State Time Standard in at least one event in a sanctioned meet.</p> <p>Georgia Swimming Short Course Peach State Championships Time Standards</p> <p>Bonus Swims: Swimmers who have qualified for an event in either session may swim up to three bonus events during the meet, in the 50y, 100y or 200y distances. The 500 yard Freestyle cannot be a Bonus Swim option). Bonus Swims can be used on any day. Bonus Swims count towards the daily event limit.</p> <p>Bonus Swims must be marked as such on the event file. Failure to do so will result in the automatic removal of a swimmer from the Bonus Swim. Teams must submit an entry report that includes Bonus Swims designated as such.</p> <p>Daily Limits: Swimmers may swim a maximum of four individual events per day.</p> <p>Relays: Only two relays per team are permitted to score, all other teams will be considered exhibition. Relay teams must be made up of swimmers from the same club and cannot include unattached swimmers.</p>

	<p>500 Freestyle: The 500 Freestyle will be a positive check-in event. Only the swimmer or their coach may check an athlete in. The positive check-in deadline will be 9:00 AM on Sunday 2/15/26. Athletes not checked in before this deadline will not be seeded. Meet management reserves the right to alternate girls and boys heats and/or combine heats of girls and boys to maintain a reasonable timeline. Swimmers must provide their own counters.</p> <p>Seeding: Any swimmers entered with “SCM,” or “LCM” qualifying time will be seeded below all swimmers with qualifying “SCY” times (YSL order). Bonus Swims will be seeded below qualified swims in the same order. All events will be pre-seeded after the Entry Deadline has passed.</p> <p>Deck Entries: Deck entries can be made at the Clerk of Course up to 1 hour before the start of the Prelims or Timed Finals sessions based on lane availability. No new heats will be created. Payment for deck entries must be made by cash or check to the Clerk of Course at the time of entry (NO EXCEPTIONS).</p> <p>Time Trials: Time Trials will be available after each session. Swimmers must be qualified for the meet in at least one individual event to be eligible for a Time Trial. Swimmers are limited to no more than 3 Time Trials. Time Trials WILL count towards daily event limits. Payment for Time Trials must be made by cash or check to the Clerk of Course at the time of entry (NO EXCEPTIONS).</p>
PROOF OF TIMES:	<p>Swimmers who enter this State Championship meet must have achieved a time equal to or faster than the Peach State Qualifying Time for each event except those designated as Bonus Swims. Times must be achieved between February 15, 2025, and February 13, 2026. The final results for each event will be reviewed by the designated representative appointed by the LSC Chair to determine each swimmer’s eligibility for this meet. If a swimmer fails to achieve the qualifying standard at this meet and cannot prove that he/she achieved the qualifying standard during the qualification period, then Georgia Swimming, Inc. will invoke a fine of \$50.00 against the team of said swimmer, or against the swimmer, if unattached, for each non-qualifying time.</p> <p>All entry files must be submitted with a proof of times report. Entries submitted without the proof times report will not be accepted.</p> <p>ANY SWIMMER WHO FAILS TO ACHIEVE OR PROVE AT LEAST ONE QUALIFYING TIME WILL ALSO BE FINED FOR ALL BONUS SWIMS ENTERED AT THE MEET.</p> <p>The SWIMS database will be the final source document used to verify proof of time for this meet. Times achieved in AAU or unsanctioned meets will not be accepted as proof. Failure to pay fines as prescribed by Georgia Swimming Rules and Regulations 7.2, Inc. will result in the barring of said team/individual from participating in any meets until such time as the fine is paid in full.</p> <p>To pay fines, make checks payable to “Georgia Swimming.” Proof of times are not required for relays</p>

Entries must include the USA Swimming Club Code and each swimmer's USA Swimming number, first and last name, age, and seeding time for each event entered.</p>
RULES:	<p>Current USA Swimming Rules will govern this meet.</p> <ul style="list-style-type: none"> • All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming <u>Minor Athlete Abuse Prevention Policy</u> ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. • On Deck USA-S registration will be permitted at the discretion of the Meet Director and/or Meet Referee. • In compliance with <i>USA Swimming Rules and Regulations</i>, the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, restrooms, or locker rooms. Per GA Swimming policy, the use of equipment capable of taking pictures (e.g., cell phones, cameras, etc.) is banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods. • Deck changes are prohibited. • Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. • Operation of a drone or any other flying apparatus is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
CREDENTIALS:	<p>Only athletes, USA Swimming certified coaches, and USA Swimming officials, in good standing, will be permitted on the deck. Coaches and Officials should have proof of active USA Swimming membership with them at all times. Parents not working the meet as a volunteer are not permitted on deck.</p>
COACHES MEETING:	<p>Coaches will be required to sign in at the Clerk of Course desk to verify their credentials, via SWIMS 3.0, are in good standing with USA-S and their respective LSC. The Coaches' Meeting will take place on Tuesday, February 10, 2026 via Zoom at 8:00 PM. Further information will be provided by email to coaches once entries are received.</p>

OFFICIALS:	<p>ASL welcomes visiting officials and apprentices and will appreciate help in officiating this competition. There will be an officials' meeting 1 hour prior to the start of each session. The official's uniform will consist of a white polo collared shirt, navy blue shorts, skirts or slacks with white socks and white shoes. All officials must present at check in, their current LSC Officials Certification Card; OR a recently completed Apprentice Form; AND proof of current USA Swimming Non-Athlete membership. AWARDS:	Awards will be given to 10 & Under swimmers only and will be given to 8th place.
SCORING:	<p>Individual and Relay events will be scored for 10 & Under swimmers only and will be scored to 16th place.</p> <p>Individual Events: 20-17-16-15-14-13-12-11-9-7-6-5-4-3-2-1</p> <p>Relay Events: 40-34-32-30-28-26-24-22-18-14-12-10-8-6-4-2</p>
