We understand that we must supply dining hall paper products during our stay if GCR is not providing the meals for our group. Paper products not provided include plates, cups, napkins, plasticware, etc. Bathroom paper products are provided by GCR.

We understand that we will be responsible for any damage to any camp property during our rental period. We are to leave the camp in the same or better condition than when we found it. We will be responsible for any special set-up that may be specifically applicable for our retreat.
