## Payment and Policy Information

We are here to assist you in your time of need. You are purchasing our services and a "FUNERAL SERVICES PURCHASE AGREEMENT" (Contract) will need to be signed. Changes may be made verbally after the initial signing but our policy is that the charges need to be paid prior to the completion of these services. If charges are not paid in full at the time of signing the Contract, an additional "Financial Agreement" must also be executed acknowledging the method, timing and additional fee's to be paid. We accept cash or check as well as Visa, American Express, Discover and Master Cards. **If a credit card is used as the method of payment, a 3% surcharge will be added to the final cost of the arrangement. Spangler Mortuaries WILL bill an estate or file an insurance claim but additional fee's will be added.** These will be explained on the Financial Agreement if this is the chosen manner of payment. Insurance and Estate options are **NOT** available for Discounted Package arrangements.

## DISCOUNTED PACKAGES

We have designed our pricing based on providing as many options as possible so families may select what best suits their needs and desires. It is your right to select **ONLY** those items you wish to pay for. You may choose from our itemized list on pages 4- 7. You do not have to pay for anything you do not use and may choose to purchase merchandise from any vendor.

Discounted packages are available only to families who purchase **ALL** merchandise through Spangler Mortuaries. *These packages are offered at a discount from the itemized General Price List and must be paid prior to the rendering of services.* You may add any individual item to these packages at their list prices. Items within the packages that are declined cannot be deducted from the special Package price.

Discounted packages are priced for standard removal/transfer to funeral home within normal business hours (Mon-Fri 9-5PM) and any removal/transfer outside of those hours will be charged an Overtime Removal Fee. Church or Chapel services conducted through the purchase of a package will occur during normal working hours (Mon-Fri 9-4:30PM) and any service outside of these hours will be charged for after hours service. These packages do not include Death Certificates or any third party fees (coroner's fees, airline fees, service to spread cremated remains, receiving Funeral Director's charges, etc.). Any addition of Spangler services or third party fees (cash accommodations) will be added to the discounted package price.

### **#1 2 DAY TRADITIONAL FULL SERVICE Package ...\$5,945 Itemized \$6,325**

This packages includes basic professional services by Funeral Director and staff, standard local removal/transfer to funeral home within normal business hours, embalming, dressing, casketing, hair, cosmetics, labor involved to file all standard paperwork (Death Certificate and Permit) as well as other administrative details, use of facilities for visitation or rosary (4 HRS) the evening before the funeral service. A funeral service at our facility (4 HRS) or church immediately followed by graveside is also included. We will provide a funeral hearse with driver and use of AV equipment at Spangler's as well.

### **#2 1 DAY TRADITIONAL FULL SERVICE Package ...\$5,045 Itemized \$5,425**

This packages includes basic professional services by Funeral Director and staff, standard local removal/transfer to funeral home within normal business hours, embalming, dressing, casketing, hair, cosmetics, labor involved to file all standard paperwork (Death Certificate and Permit) as well as other administrative details and use of facilities for a funeral service at our facility (4 HRS) or church immediately followed by graveside. We will provide a funeral hearse with driver and use of AV equipment at Spangler's as well.

### **#3 ALTERNATIVE BASIC SERVICE & GRAVESIDE Package...\$4,345 Itemized \$4,950**

This package includes basic professional services by Funeral Director and staff, standard local removal/transfer to funeral home within normal business hours, embalming, dressing, casketing, hair, cosmetics, labor involved to File all standard paperwork (Death Certificate and Permit) and other administrative details, up to 3 hour visitation followed by graveside, use of hearse and driver to cemetery.

### **#4 SHIPMENT TO OTHER FUNERAL HOME WITH VIEWING Package...\$4,245 Itemized \$4,650**

This packages includes basic professional services by Funeral Director and staff, standard local removal/transfer to funeral home within normal business hours, embalming, dressing, casketing, hair, cosmetics, labor involved to file all standard paperwork (Death Certificate and Permit) as well as other administrative details and 1 hour viewing in one of our small chapels, shipping liner (required by airlines), transportation to airport (SJC).

**#5 RECEIVING FROM OTHER FUNERAL HOME VIEWING & GRAVESIDE**

This packages includes basic professional services by Funeral Director and staff, standard local removal/transfer to funeral home from airport (SJC) refrigeration, re-filing out of state burial permit by hand for a California state permit and 3 hour visitation immediately followed by graveside. A funeral hearse with driver will also be provided.

Same as a 1 Day Traditional Full Service (Package 2) and includes the witness casketed cremation before 2pm on a weekday fee. Charges for a casket or other merchandise are not included and Spangler's does not offer rental caskets. The state cremation fee is also included.

**#8 FAMILY "FAREWELL" VIEWING&WITNESS CREMATION Package...\$4,870** Itemized \$5,387

This packages includes basic professional services by Funeral Director and staff, standard local removal/transfer to funeral home within normal business hours, embalming, dressing, casketing, hair, cosmetics, labor involved to file all standard paperwork (Death Certificate and Permit) as well as other administrative details, up to 3 hour visitation on a table or cremation container, transport to Wyant and Smith Crematory by hearse and witness basic cremation (before 2pm) fee. Charges for a casket or other merchandise are not included and Spangler's does not offer rental caskets. The state cremation fee is also included.

**#9 DIRECT CREMATION WITH MEMORIAL SERVICE Package ...\$3,940** Itemized \$4,357

This package includes basic professional services by Funeral director and staff and local removal and transfer to funeral home. Refrigeration of remains and filing of all necessary paperwork (Death Certificate and Permit) as well as other administrative necessities. Delivery to Wyant and Smith Crematory and basic cremation to be completed at Spangler's convenience. Use of facilities for memorial service with Funeral Director and staff or coordinating memorial service at church or other facility. Use of AV equipment, and Reception room (on site). Charges for a casket or other merchandise are not included and Spangler's does not offer rental caskets. The state cremation fee is also included

**#10 DIRECT CREMATION Package...\$2,895** Itemized \$3,279.91

This package includes basic professional services by Funeral director and staff and local removal and transfer to funeral home. Refrigeration of remains and filing of all necessary paperwork (Death Certificate and Permit) as well as other administrative details. Delivery to Wyant and Smith Crematory and cremation, at Spangler's convenience. Plastic urn, Standard cardboard cremation container, tax, filing fee and state cremation fee are included.

The goods and services listed below are those that we can provide to our customers. We are a privately owned crematory that provides services through Spangler Mortuaries. We do not provide services to the general public. The charges below that you select will be added to the Mortuary Purchase agreement. The average cremation time is approximately 4 hours. Cremated remains will be available for release the day following the creation as long as the urn is available. ALL DECEDENTS MUST BE ENCASED IN A DURABLE LEAK PROOF CONTAINER BEFORE CREMATION FOR HEALTH REASONS AND PER STATE LAW CAN ONLY BE RELEASED INCASED IN A DURABLE CONTAINER (an Urn). Cremated remains can only be held by Spangler Mortuaries for a maximum of **30** days UNLESS a contract for temporary storage has been signed. Under no circumstance will Spangler's hold for more than 365 days. If the cremated remains are not retrieved within the allotted time frame, three attempts will be made by Spangler Mortuaries to contact the next of kin by calling and/or e-mailing the number or e-mail address on file. If such attempts fail and the next of kin makes no attempt to retrieve the cremated remains, the cremated remains will be considered abandoned. Spangler Mortuaries will then report the abandonment to the Santa Clara County Coroner. Such abandonment will result in forfeiture of the right to control the disposition of the cremated remains. Spangler Mortuaries makes no guarantee of the results of such abandonment.

**Direct Cremation**.....

*Our PACKAGE charge for this service (without ceremony) includes basic services of funeral director, transfer of remains to funeral home within 20 mile radius, sheltering of remains for one day, transportation to Spangler Mortuaries owned, Wyant&Smith Crematory in Sunnyvale AND THE BASIC CREMATION CHARGE (cremation requested and performed at other facilities requires additional transportation) and necessary authorizations (Alternative container/casket, basic urn & filing fee included).*

With the exception of the SPANGLER MORTUARY OWNED, Wyant & Smith Crematory, the actual act of cremation is performed only at cemeteries. All cemetery cremation charges are subject to change by each individual cemetery. Spangler Mortuaries will arrange for cremation with any crematory the family requests.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without covering). The container we offer is a cardboard container. Cloth covered cardboard containers with handles and laminated fiberboard containers with handles are available by special order.
