Privacy Policy

By accessing the Benefits, you consent to the collection and Use of your Private Information by KMS.

INFORMATION KMS MAY COLLECT

- When you register with KMS, your name, email address, phone number.
- If you correspond with KMS by e-mail, KMS may retain the content of your e-mail messages, your email address, and KMS responses.
- While interacting with other users on an interactive area your messages are not private and can be viewed by any member or user of the Website.
- Any information or details you post on the Website
- When you access the Benefits, KMS will automatically collect information about you, including:
