

MISS ROCKLAHOMA 2026

OFFICIAL CONTEST ENTRY AGREEMENT, RELEASE, PUBLICITY CONSENT & LIABILITY WAIVER

This Agreement is entered into between Rocklahoma Festival, its parent companies, affiliates, owners, officers, employees, contractors, sponsors, venue partners, successors and assigns (collectively, "Sponsor"), and the undersigned applicant ("Participant"). By signing below, Participant voluntarily seeks entry into the Miss Rocklahoma 2026 Contest and agrees to all terms.

1. Eligibility

Participant represents she is at least twenty-one (21) years of age, legally eligible to participate, possesses valid identification, and has obtained valid admission credentials to Rocklahoma 2026.

2. Sponsor Discretion

Sponsor reserves the sole and absolute right to administer, modify, suspend, cancel, interpret, or revise any portion of the Contest, judging, scheduling, finalist selection, prizes, or appearances.

3. Publicity / Likeness Grant

Participant irrevocably grants Sponsor a perpetual, worldwide, royalty-free, transferable, sublicensable right and license to photograph, record, reproduce, edit, publish, distribute, display, broadcast, advertise, exploit, and otherwise use Participant's name, nickname, image, likeness, voice, persona, biography, statements, photographs, videos, social media content, and appearance in any media now known or later developed, for any lawful promotional, commercial, editorial, archival, merchandising, or advertising purpose, without notice, approval, or further compensation.

4. Waiver of Compensation

Participant expressly waives any right to inspect materials or receive payment, royalties, residuals, fees, or other compensation arising from Sponsor's authorized use of Participant's likeness or materials.

5. Code of Conduct

Sponsor may disqualify or remove Participant for intoxication, illegal drug use, violence, threats, harassment, fraud, obscenity, hateful conduct, criminal behavior, failure to appear, reputational harm, or any conduct Sponsor deems inconsistent with Contest standards.

6. Winner Duties

If selected, Participant agrees to reasonably participate in interviews, stage appearances, fan interactions, sponsor promotions, social content, photography, and ambassador duties.

7. Assumption of Risk

Participant voluntarily assumes all risks associated with travel, attendance, backstage areas, crowds, weather, staging areas, photography areas, and festival participation.

8. Release / Hold Harmless

Participant releases, waives, discharges, and covenants not to sue Sponsor from any and all claims, liabilities, demands, damages, losses, costs, attorneys' fees, or causes of action arising out of participation or attendance, including personal injury, property damage, emotional distress, defamation, publicity claims, negligence (to the fullest extent permitted by law), or other alleged harm.

9. Indemnification

Participant agrees to defend, indemnify, and hold harmless Sponsor from claims or liabilities arising from Participant's acts, omissions, misconduct, breach of this Agreement, or violation of third-party rights.

10. Revocation of Title

Any title, placement, finalist status, credential, or prize may be revoked at any time for rule violations or conduct harmful to Sponsor.

11. No Employment Relationship

Nothing herein creates employment, partnership, agency, or entitlement to future work.

12. Governing Law / Venue

This Agreement shall be governed by Oklahoma law. Exclusive venue for disputes shall be in a court of competent jurisdiction located in Oklahoma, unless Sponsor elects arbitration.
