Job Summary:	We are seeking a certified Summer Lifeguard to assist with preparing the waterfront for families. This role involves assisting with boats, preparing and cleaning up the beach, and watching the waterfront to ensure everyone is safe. The ideal candidate is a certified adult with experience serving as a lifeguard for children.
Key Responsibilities:	• Rake sands and set up beach for waterfront hours. • Works with boat drivers to fuel, cover/uncover boats, and lift boats out of the water. • Put away and lock up waterfront items (i.e. kayaks, tubes, canopy, and life jackets). • Supervise and ensure all participants are adhering to waterfront safety guidelines. • Perform water rescue in case of emergency.
