

Annual Biometric Screenings

We are pleased to announce that our 2026 Onsite Biometric Screenings Registration window will open from 1/19/2026 to 2/6/2026. If onsite screening is not available for you, **LabCorp screenings are available from 1/19/2026 to 3/31/2026.**

As part of the Lifestyle Rewards program, employees must earn a minimum of 200 points through our Wellness Program **to qualify for the Wellness Reward** for the benefit plan year starting July 1, 2026. The wellness reward **provides a discount in the medical premiums.** The voluntary biometric screening is available for all regular full-time and seasonal employees, enrollment in HMC's medical plan is not required. Spouses are eligible for the screening if enrolled in our medical plans.

Results from the biometric screening also awards points toward the required 200 points. Please see attached **Wellness Program Guide** for a complete listing of all activities available to earn wellness credits.

Participation in our overall Wellness Program is voluntary. Take part in the **biometric screening and health assessment survey** to unlock the wellness rates for your medical coverage from **July 2026 through June 2027.** Points for both activities account for 125 of the minimum 200 points.
