Don Sneed is a Tribal Planning Program Manager and Tribal Liaison with the Arizona Department of Transportation (ADOT) Multimodal Planning Division. Don is an enrolled member of the Gila River Indian Community and has been employed with ADOT for 21 years. At ADOT Don provides technical tribal transportation planning support and state-tribal intergovernmental coordination and consultation for ADOT's statewide and regional planning programs and projects. Since 2003, Don has also managed and participated in the development of numerous ADOT funded tribal long range transportation plans, tribal project pre-scoping reports and tribal roads safety assessments. Additionally, as one of two ADOT Tribal Liaisons he works to address development of mutually compatible intergovernmental relations between ADOT and the tribal governments in Arizona by working cooperatively with various tribal, local, state, and federal agencies. He functions as an in-house expert on tribal issues and is accountable to maintain compliance with federal and state laws, regulations and policies.
