

## **W3 Formats**

There are two acceptable formats for filing electronically with the Village of Bluffton.

### **1. Federal Filing Format - MMREF and EFW2**

Information about the Federal MMREF and EFW2 formats are available on the Social Security Administration website at: [www.ssa.gov/employer](http://www.ssa.gov/employer). Both formats are very similar and can both be read. See page 5 for Ohio House Bill 5 related modifications to these standards.

Note that the record with local information is not required for filing federally. However, the RS record must be included to provide city information.

### **2. CityTax Proprietary Format (CTP)**

This is a simple format for a single employer. It may be created using Microsoft Excel. It is a Comma Delimited format. More details can be found on the following pages.

The following table lists critical fields, with the location in the format.

## CityTax Proprietary

This is a comma-delimited format. That means that each field is separated by a comma. See below for instructions on creating this file from Microsoft Excel. All text must be in upper case. If leading zeros on TaxIDs or Zip Codes do not show, this is all right.

## How to Create CTP format using Microsoft Excel

Note: All dollar amounts should be entered as a normal number with decimal point, such as 15100.50

1. Open a new spreadsheet.
2. On the first line, enter the Employer data as specified above, entering one value per column. The letter shown at the start of each line must match the letter at the top of the column in Excel. Skip the column if blank. Ensure all entries are upper case. To start, enter 'CTE' in the first column.
3. For each employee, enter another line. Enter CTE in first column (A) and enter one field per column.
4. Click on the Save button (or select Save from the File menu). At the bottom is a drop-down box for Save as Type. Click on this drop-down and select: 'CSV (Comma delimited) (\*.csv)'
5. Then enter a file name and click Save.
6. Copy this file to a thumb drive and deliver it to the Bluffton Income Tax office located at 154 N. Main St., Bluffton, OH 45817. You may also send the file by email but please make sure the email is encrypted.

## **Optional Changes Specific to Ohio House Bill 5 changes: 2016**

### **Paper and Electronic Media W-2 Reporting Requirements**

A W-3 Reconciliation and W-2's are required to be filed on or before the last day of February following any calendar year in which employee withholding has been made by an employer. The form must accompany all W-2 copies, computer paper listings, or electronic media.

A 1099 transmittal sheet is required to be filed on or before the last day of February following any calendar year in which an employee receives 1099-MISC, rents, other income, non-employee compensation, or excess golden parachute payments.

Employer W-2 submission specifications changed as the result of House Bill 5, enacted by the Ohio General Assembly. Employers are now required to report for each employee - the specific municipality or municipalities for which tax is withheld or should be withheld. This requirement has updated certain fields for the magnetic reporting of W2s (EFW2) specifications as bulleted below.

CityTax uses Position 5-9 of the RS record, referred to as the "Taxing Entity Code" field as defined by SSA. Expected Codes for Ohio Cities are listed on pages 8-12 of this document. Refer to the RS record example listed further down in this document.

Use Position 338-412 of the RS record, referred to as the "Supplemental Data 1" field as defined by SSA to report the full name of the municipality name for which tax was or was required to be withheld.

In cases where an employer withholds for more than one location or for both workplace and residence tax, a separate RS record should be used for each municipality.

All electronic media reporting for W-2 Copy A information must conform to the Social Security Administration's electronic media reporting and filing guidelines (EFW2).

Employers with 10 or more W-2 Copy A forms must report on electronic media using EFW2 guidelines.

Employers with less than 10 W-2 Copy A forms may report on electronic media but must use the EFW2 guidelines.

All electronic media must be affixed with an external label showing: (A) Submitters Name (B) Submitters Address (C) Submitters 10-digit Telephone Number and (D) Submitters information must agree with internal code "RA" record data.

### Examples of RS Records

The Local Taxable wages and Local Income Tax withheld should reflect the wages earned and Tax Paid for each individual.

#### EXAMPLE 1 - Reporting multiple workplace locations.

Multiple RS records are used to report the state and local wages. If the Employee Earned Wages in the following municipalities:

\$10,000.55 in Brecksville

\$15,456.28 in Middleburg Heights

\$20,000.00 in Hudson

There would be (3) RS Records:

(A) Information in positions 1 thru 4 and 10 thru 308 would be the same in all 3 Records.

#### **EXAMPLE 2 - Reporting Workplace and Residence Tax Withheld.**

Wages should not be repeated for the residence tax withheld. If the employee earned wages in their work municipality of Strongsville and lives in North Royalton, two RS records are used.

(A) Information in characters 1 thru 4 and 10 thru 307 would be the same in both records.

**Federal Filing Format-MMREF-1 or EFW2**

Note that the record with local information is not required for filing federally. However, the RS record must be included to provide city information.

**CityTax Proprietary Format (CTP)**

This is a simple format for a single employer. It may be created using Microsoft Excel. It is a Comma Delimited format. Details are shown below.

### **Using Excel to Submit W2s electronically**

All text must be in upper case. If leading zeros on Social Security Numbers or Zip Codes do not show, this is all right. All dollar amounts should be entered as a normal number with a decimal point, such as 15100.50 Do not leave blank lines between information.

1. Open a new spreadsheet.
2. On the first line, enter the Employer data as specified below, entering one value per column. The letter shown at the start of each line must match the letter at the top of the column in Excel. Skip the column if blank. Ensure all entries are in upper case. To start, enter 'CTE' in the first column.
3. For each employee, enter another line. Enter CTW in first column (A) & enter one field per column.
4. Click on the Save button (or select Save from the File menu). At the bottom is a drop-down box to set the Save as Type. Click on this drop-down and select: 'CSV (Comma delimited) (\*.csv)' Then enter a file name and click Save.
5. Copy this file to a thumb drive and deliver it to the Bluffton Income Tax office located at 154 N. Main St. Bluffton, OH 45817.
