Sealed proposals will be received by the Lenawee County Road Commission at their office, 2461 Treat Highway, Adrian, Michigan until 1:00 p.m., Tuesday, February 12, 2026 at which time the proposals will be publicly opened and read for the following:

ROUTING & CRACK FILLING WITH A SEALTIGHT 3405 POLYMERIC COMPOUND

The above material must meet current Michigan Department of Transportation specifications or Lenawee County Road Commission specifications.

Proposals will be accepted on Road Commission form **Only** and are to be in a sealed envelope plainly marked

“ROUTING & CRACK FILLING BID – 2026”

Bids will be publicly opened, read and available for review at the time specified. Following the bid opening the bids are reviewed by various staff members in order to make a recommendation to the County Board of Road Commissioners at its next regular meeting. During this time period the bids are closed and information regarding the bids is not available. Bids will be awarded at the next regularly scheduled Board Meeting of the Board of County Road Commissioners following the due date for receipt of bids.

The right is reserved to accept or reject any or all bids or any part of same, to waive irregularities and/or informalities in bids and to make the award in whole or in part as may appear to be in the best interests of the Lenawee County Road Commission and Lenawee County.

PRODUCT REQUIREMENT:

Sealtight 3405 polymeric compound.

USE & APPLICATION:

The sealtight 3405 polymeric compound will be melted in an oil-jacketed melter/applicator equipped with an agitator and separator. Temperature thermometers for oil bath and melting vat. Melt only sufficient material to be used the same day. Material may be added as the sealant is withdrawn. The sealing may be done at air temperatures of 40° F or higher. At the end of each day's sealing operation, all material must be drawn off.

Application of sealant into frozen or wet pavement will not be allowed.

Heating of material over 390° F will be prohibited.

All cracks are to be routed with a rotary router, when required, or cleaned with compressed air (overband), when required. Routing should be slightly larger than the existing crack to ensure proper adhesion to sidewalls. No pin routing will be allowed. No heat lansing will be allowed. Along with routing, the cracks will be blown out with compressed air. All cracks shall be dry and properly cleaned of all loose material; wire brushing, where applicable.

CONTRACTOR REQUIREMENTS:

The successful bidder will be required to furnish proof of the following types of insurance coverage:

- a. Workmen's Compensation (Statutory Requirements)
- b. Public Liability and Property Damage in a minimum amount of \$1,000,000.00 naming the Lenawee County Road Commission as an additional insured. The wording of the additional insured provisions shall be as follows:

“The Board of Lenawee County Road Commissioners, the Lenawee County Road Commission and their officers, agents and employees are named as additional insured parties.”

Signage shall conform to the latest version of MMUTCD as adopted by MDOT

References and volumes of previous jobs are to be provided to the road commission with the proposal.

The road commission will require a warranty on material and labor and is to be written on the proposal sheet.

The bid prices shall be based on the list of road names below. Each road shall be bid separately, unless noted. The Lenawee County Road Commission reserves the right to award the bid based on individual roads or in groups of roads, whichever is in the best interest of the Road Commission. All crackfill work must be completed prior to June

If the Road Commission or a township decides not to route and crack fill one or more of the roads listed, then the bid for that road (or roads) shall be considered void and the work will not be performed. Work shall not commence until the bidder has written notification.

The Lenawee County Road Commission will have the right to sample all material and test same. Any material not meeting the aforementioned specifications may be rejected.
