Director of Operations Schnaidt updated the board on the 2 Yankee Rd projects. Yankee Rd – Treat to Arnold, slag has now sat for a month, it has progressively gotten

worse with segregation of material. Yankee Rd – Treat to Neuroth, we tried a new chip seal process on Yankee Road. The results of both projects are not to our standard of quality, and we will be pulverizing both sections and then placing 2" limestone on the Treat to Arnold section and asphalt on the Treat to Neuroth section.
