

## Log Splitter Competition – Terms & Conditions

### 1. Promoter

The Promoter is – Albury Consolidated Industries Pty Ltd - ABN 34 087 962 338 (WISELIVING) of 89 North Street East, Albury NSW 2640  
The Promoter is referred to as: WISELIVING

### 2. Promotion Period

The promotion commences at 12:00am AEST on 1 April 2026 and closes at 11:59pm AEST on 31 August 2026 (“Promotion Period”). Entries received outside the Promotion Period may not be accepted.

### 3. Definitions

For the purposes of these Terms and Conditions:

- **Eligible Product** means any WISELIVING Thermalux wood-fired stove, cooker or boiler purchased and paid in full, at the recommended retail price from an authorised retailer including direct from WISELIVING during the Promotion Period.
- **Entry** means a valid submission made in accordance with these Terms and Conditions.
- **Immediate Family Member** means spouse, partner, de facto partner, parent, child, sibling, or household member.
- **Prize** means the BBT 9 Ton Vertical/Horizontal Electric Wood Log Splitter described in clause 9, or any substitute prize of equal or greater value provided in accordance with these Terms and Conditions.
- **Winner** means the entrant selected in accordance with clause 10.

### 4. Eligibility

1. Entry is open to Australian residents aged 18 years or older.
2. To be eligible, entrants must:
  - a) purchase an Eligible Product during the Promotion Period and have paid the full purchase price; and
  - b) submit valid proof of purchase in the form of a tax invoice or receipt.
  - c) provide all personal information required by WISELIVING to administer the promotion, including full name, date of birth, residential address, and contact details.
3. The following persons are **not eligible** to enter:
  - a) any Dealers, Retailers, Distributors or Installers of WISELIVING products;
  - b) any employees, contractors, or agents of WISELIVING Pty Ltd, including temporary, casual, or part-time staff;

### 5. How to Enter

3. One (1) Entry is permitted per Eligible Product purchased.
4. Multiple purchases allow multiple Entries, provided each Entry relates to a separate Eligible Product.

6. Where required by law, a single alternative entry is available and may be submitted in writing to WISELIVING Pty Ltd, PO Box 565, Albury NSW 2640. Submissions must include the entrant's full name, address, and date of birth. Only one entry per person will be accepted. Entries via this method will be used solely for the purposes of this promotion in accordance with WISELIVING's Privacy Policy. ## 6. Entry Conditions
