# **Meeting Purpose**

Annual meeting of Copper Valley HOA to discuss community updates, financials, maintenance projects, and board elections.

# **Key Takeaways**

- Major heating system upgrades planned for October, including installing isolation valves (~\$1000-1200 per unit) to be funded from reserves
- Carpet replacement (~\$55k) and painting (~\$16k) planned for fall if carpet available, otherwise delayed to spring
- HOA dues will increase to fund projects rather than special assessment
- Four board members re-elected: Michelle Bob, Steve Vale, Lori Adam, and new member John Farmer

# **Topics**

## **Financial Update**

- Operating account: \$65k (high, \$20k to move to reserves)
- Reserves: \$204k currently, potentially up to \$224k
- Roof loan to be paid off in October, freeing up \$4,700/month for reserves
- Insurance costs expected to increase again

### **Maintenance Projects**

- Sauna repairs ongoing, new parts ordered
- Major water pipe and shutoff valve repairs completed
- Backflow valve repairs planned
- Door repairs completed in laundry room
- Parking pass placards ordered, temporary passes available for rentals

## **Heating System Upgrades**

- Plan to install isolation valves in all units (~\$1000-1200 per unit)
- Will allow individual unit repairs without shutting down whole building
- To be funded from reserves as common element
- Scheduled for October 13-17, no heat during work

### **Carpet and Painting**

- Carpet replacement estimated at \$55k
- Painting estimated at \$16k, includes north corridor banister
- Plan to complete in October if carpet available, otherwise delay to spring
- Will increase dues to fund rather than special assessment

#### **Pool and Exterior**

- Pool refinishing and concrete work around pool area tabled until spring
- Considering removing flower bed to address prairie dog issues
- Will get estimates and discuss further at spring meeting

#### **Board Elections**

- Four seats open: Michelle Bopp, Steve Vale, Lori Adam re-elected
- New member John Farmer elected
- Board now at 7 members total

### **Development Concerns**

- Reports of potential development behind building
- Suggestion to form committee to monitor and report on any plans

## **Next Steps**

- Schedule heating system upgrades for October 13-17
- Finalize carpet selection and order if available for October installation
- Schedule painting for early October before other work
- Increase HOA dues to fund projects (exact amount TBD)
- Form committee to monitor potential nearby development
- Send follow-up on parking passes and temporary rental passes

## **Action Items**

- Check w/ Scott Phillips (Karbowski) re heat tape installation confirm 3ft up on roof not just 2ft
- Email owners re domestic water valve replacement send form, deadline Oct 10, schedule for Oct 16-17
- Organize valve replacement project schedule for Oct 13-17, coordinate w/ plumbers, notify residents
- Schedule painters for week of Oct 6-10, coordinate w/ valve replacement project
- Order carpet if available for installation after valve replacement (Oct 13-17)
- Email owners re carpet/paint selection process, share options, solicit feedback
- Email owners requesting volunteers for development monitoring committee, report to board next meeting
