The goods and services shown below are those we can provide to our customers. You may choose only those items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

1. Basic services of funeral director and staff**\$ 2,690.00**

Our fee for services of the funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement co-creation with family or responsible parties; arrangement of funeral; preparation and filing necessary authorizations and permits; preparation and placement of obituary notices; staff assistance prior to, during and following the Life Celebration events. Also included in these charges are overhead relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, equipment and inventory costs. This fee for our basic services and overhead will be added to the total cost of the funeral you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

2. Embalming**\$ 689.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

3. Other preparation of the body**A. Cosmetology, dressing and casketing****\$ 197.00**

Cosmetology is an art form that can include basic application of cosmetics to extensive restorative procedures. Dressing and casketing includes dressing of the body to the family's request and placement and positioning of the body in the casket or container selected.

B. Sanitary handling of remains for cremation or immediate burial**\$ 259.00**

This charge is applied to services where embalming will not take place; it includes refrigeration (up to 48 hours) and procedures to ensure the safety of our team and compliance with universal precautions. It may include washing or disinfection of the body, single use products or placement of the body in the cremation container/casket selected. If refrigeration is required for more than 48 hours then a \$75/day refrigeration fee will be applied.

C. Special care of autopsy**\$ 295.00**

This charge is for the additional hours and material required for embalming the body following an autopsy.

4. Additional services and facility fees**A. Use of facilities, staff & equipment for viewing or visitation****\$ 597.00**

This charge is for (1) up to 3-hour *published* session on the day before the funeral. It includes the use of the funeral home, staff, accepting delivery and set-up of flowers or other items. If the family *chooses* additional visitation time it will be billed hourly at \$150/hour.

B. Use of facilities, staff & equipment for private viewing/visitation one hour prior/reception**\$ 297.00**

This charge is for a private viewing before cremation, a public visitation prior to the service or a reception at the funeral home on the same day of the funeral. Additional time will be billed at \$150/hr.

C. Use of facilities, staff & equipment for a memorial service**\$ 697.00**

This charge is for a memorial service (without the body present) at a location of the family's choice.

D. Use of facilities, staff & equipment for a funeral service**\$ 697.00**

This charge is for a funeral service (with the body present) at a location of the family's choice.

E. Use of staff for a memorial service in a church or other facility**\$ 697.00**

This charge is for a funeral service (with the body present) at a location of the family's choice.

F. Use of staff & equipment for a funeral in a church or other facility**\$ 697.00**

This charge is for a funeral service (with the body present) at a location of the family's choice.

G. Use of staff & equipment for a graveside ceremony**\$ 697.00**

This charge is for a funeral or a memorial service at the final resting place of the deceased.

H. Spring committal fee**\$ 350.00**

This charge is for additional time associated with coordinating a burial in the spring and storage in our on-site receiving vault.

I. Saturday charge**\$ 475.00**

This charge is for any *arranged* services that take place on a Saturday. This charge will not be applied to immediate need services.

J. Filling of 3rd party containers with cremated remains (\$10 each additional)**\$ 25.00**

This charge is for the time and liability associated with filling a 3rd party container with cremated remains.

5. Transfer of Patient from the place of death

This charge is for our team to transfer a patient from the place of death. It includes use of staff (available 24 hours a day and 365 days a year) equipment and any single use items. Add \$250 to this charge for families not using Goss Funeral Services for disposition.

This charge includes 50% of our basic services of funeral director and staff, use of staff & equipment for a graveside service and transportation of remains to a local cemetery. This charge does not include any merchandise or cash advance items.

This charge includes 50% of our basic services of funeral director and staff, use of staff & equipment for Life Celebration events and auto equipment. This charge does not include any merchandise or cash advance items. The package price is only available when disposition occurred out of state.

This charge includes basic services of funeral director and staff, local patient transfer from the place of death, sanitary handling of remains for direct burial and transportation to a local cemetery. This charge does not include any rites or ceremonies, merchandise, or cash advance items.

This charge does not include any rites or ceremonies, merchandise, or cash advance items. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard.

- Our team gives everything in their tank to serve your family. It has become clear to us, in order to care for your family, we have to care for our own. Because of this, we will no longer schedule any services on Sundays, or the following dates in 2026: January 1, May 23 & 25, July 4, September 7, November 26 & 27, December 24-26, and 31.

Terms of Payment

1. Plan for payment in full must be made at the time of arrangements.
2. 50% of the contract total must be paid prior to any services rendered. The remaining balance will be due 30 days from the date of services.
3. Cash, Check, Credit Cards and Assignment of verified insurance policy are all acceptable forms of payment.
4. A 3% convenience fee will be applied to all cash advance items that are paid via credit card.
5. A 5% estate filing fee will be applied to the total contract amount, assets must exceed the value of services for approval.
