Refundable Deposit for Cremated Remains When human remains are to be cremated and the funeral home takes possession of the cremated remains, a refundable deposit will be required to be paid. If the cremated remains are not claimed within one year of the cremation, the deposit may be used to inter the cremated remains in common ground. If the cremated remains are claimed before they are interred, the deposit will be refunded	\$ 350.00

DISBURSEMENTS

Disbursements are items arranged for, and possibly paid for as a courtesy, on your behalf by the funeral home. The following are some items that are often identified as disbursements. All disbursements are charged at cost.

Newspaper or radio notices – these are charges for death notices placed in newspapers, on radio or other media outlets.

City Registration Fee – this is a fee charged by the local municipality to register the death. The fee is set by the municipality and may vary.

Clergy Offering – this is a thank offering given to the clergy at an amount to be determined by you.

Coroner's Cremation Certificate – this is a fee charged by the coroner for issuing a certificate that allows cremation to take place. The fee is set by the Chief Coroner for Ontario.

Cremation Fee – this is the fee charged by the crematorium for the actual cremation process. The crematorium will charge an additional fee for the return of the cremated remains from the crematorium to the funeral home.

Cemetery Interment Fee – this is a fee charged by the cemetery for the opening and closing of a grave (varies by cemetery). Most cemeteries have additional fees for interments on weekends or holidays.

PAYMENT AND FUNDING

Terms of Payment

Accounts may be paid by cash, personal cheque, or bank draft. Full payment is due within 30 days of the date of the contract. Beyond the allotted time, interest will be charged on any overdue amounts at a rate of 1.5% per month which is equivalent to 19.56% per annum (APR), until the date of payment in full.

Funding

For your convenience, we offer the option of prepaying services or supplies, whereby your payment is deposited into a trust account where it will accrue interest until the services and supplies are provided, or the contract is cancelled. When prepaying, you pay for the services and supplies today, and the principal and interest will be used to pay for the services and supplies when they are provided at the time of death.

If you are prepaying, pre-authorized chequing and various payment plans are also available.
