



Fuel Surcharges Policy

To ensure transparency and to reflect fluctuations in global fuel costs, Zed Logistics applies fuel surcharges to certain delivery services. Fuel surcharge rates are reviewed periodically and are based on recognised industry fuel indices.

For UK Same Day and UK Next Day services, the surcharge is linked to the consumer price of diesel fuel in Sterling (GBP), inclusive of duties and taxes, as published by the European Commission Directorate for Energy and Transport Oil Bulletin.

For International Air shipments, fuel surcharges are based on the Jet Fuel Price Monitor published by the International Air Transport Association (IATA), with prices expressed in USD per gallon.

* International fuel surcharges may vary depending on destination, airline, and market conditions. Final rates will be confirmed at the time of booking.

Fuel surcharges are applied in addition to standard transportation charges and may be amended without prior notice in line with market fuel price fluctuations.
