## **COUNCIL MEETING: OCTOBER 21, 2025**

The Town Council for the Town of Brantley met on Tuesday, October 21, 2025 at 6:00 p.m. at the Brantley Armory with the following members present: Mayor Sullivan, Steve Walker, Georgia Bush, Ashley Stewart, Darryl Elliott and Lorey Bogen. Notice of meeting was posted at Town Hall, U.S. Post Office and Brantley Library. Others present were: Diane Mears, Chief Averett, Bill Rayborn and several town residents.

Prior to council meeting, a group picture was taken of the current council members.

Mayor Sullivan said prayer, followed by the Pledge of Allegiance. Roll call was taken by Mayor Sullivan.

Councilman Stewart and Councilwoman Bush stated "it was a pleasure serving as council member for the Town of Brantley". Mayor Sullivan thanked Councilwoman Bush for stepping in during the loss of Ms. Judy Wooley and Councilman Stewart for stepping in for departing council member, Randy Hall.

Mayor read a letter received from Sherry Knight, Panama City Beach, Florida. Ms. Knight praised residents of Brantley for their assistance when she experienced a tire blowout that caused a fire to ignite. Rescue came from several people including Fire & Rescue, Police and Residents. Repairs were made by Blake Taylor and Ms. Knight was sent on her way at no charge.

Mayor mentioned the upcoming Christmas Parade – December 6 – 12:00 – 3:00 p.m.

Motion was made by Councilman Stewart and seconded by Councilman Walker to accept September 18, 2025 Minutes. Approved by Councilman Stewart, Councilman Walker and Councilwoman Bush, however Councilman Elliott stated that the September 18 meeting did not have a quorum, thus null and void.

Mayor read aloud the Resolution "CDBG Project SM-ED-PF-22-011".

Motion was made by Councilman Stewart and seconded by Councilman Elliott to accept the revised Resolution 2025-13 "CDBG Project SM-ED-PF-22-011". Approved (5-0).



Councilman Elliott stated that he had a resident contact him regarding a leak on James Street and limbs on power lines. Mayor stated that he would speak with Jim Major regarding same.

Councilman Bogen asked about work applications for water department. Clerk replied that Mayor had instructed that the position would not be open until Spring, 2026. Clerk gives a blank application to whomever requests one.
