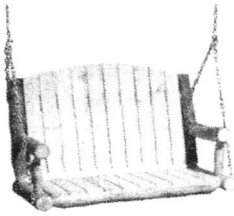

COUNCIL MEETING: SEPTEMBER 2, 2025

The Town Council for the Town of Brantley met on Tuesday, September 2, 2025 at 12:00 p.m. at the Brantley Armory with the following members present: Mayor Sullivan, Steve Walker, Ashley Stewart, Darryl Elliott, Georgia Bush, Ashley Stewart and Lorey Bogen. Notice of meeting was posted at Town Hall, U.S. Post Office and Brantley Library.

Others present were: Diane Mears, Chief Averett, and several Brantley residents.

Councilwoman Bush said prayer. Roll call was taken by Mayor Sullivan.


Motion was made by Councilman Stewart and seconded by Councilman Elliott to accept August 12, 2025 Council Meeting Minutes. Approved (5-0).

Mayor's Comments:

- Provisional Votes Opened: Results were: District 2 - Beck (1); Stewart (1); Tompkins (1) and Berry (2).
- Absentee Ballots: Results were: Pruitt (1); Berry (2); Gray (1); Stewart (3) and Tompkins (3).
- Overall Counted Votes including Machine, Provisional and Absentee were:
District 1 – Lorey Bogen (53); Darryl Elliott (49); Betty Pruitt (21).
District 2 – Scott Beck (87); Linda W. Berry (84); Karen M. Gray (51); Ashley Stewart (36); Charles Tompkins (125).

- Reminded current council to be prepared for new council photo to be taken;

Motion was made by Councilman Stewart and seconded by Councilman Elliott to approve Resolution 2025-6 "Alcoholic Beverage Control Application for Somnath, LLC"; license to be transferred from Brantley One Stop (Shree Chehar 11, Inc.) to Somnath, LLC, d/b/a Brantley Food Mart. Approved (5-0).
