USE OF DISABLED PATRIOT FUND LOGO FOR FUNDRAISING ACTIVITIES

For fundraising activities, we encourage third parties to use the Disabled Patriot Fund logo in order to generate awareness for Disabled Patriot Fund support. For logo approval please fill out the third-party event proposal form and return it to the Disabled Patriot Fund. Logo approval may take 7-14 days. Time sensitive requests will be reviewed early on a case by case basis.

The following guidelines must be followed for all use of the Disabled Patriot Fund logo:

- The logo may not be used in any manner that might imply that Disabled Patriot Fund personally endorses any business, private entity, political group, lobby organization, or any other association.
- The logo may not be displayed as a primary or prominent feature on any fund raising material. Third parties using the Logo pursuant to these guidelines must also display in the primary and more prominent position, their own logo (i.e. the primary fundraising organization).
- The logo may not be used in a manner that would disparage the Disabled Patriot Fund.
- The logo must be used as provided by Disabled Patriot Fund with no changes, including but not limited to changes in the color, proportion, or design. The logo may not be animated, morphed, or otherwise distorted in perspective or appearance. Any changes in appearance must first be approved by the Disabled Patriot Fund.
- To properly stage the logo, a minimum clearance between the logo and other elements must be maintained. Disabled Patriot Fund will provide a sample logo, no other logos are authorized.
- The logo must stand alone and may not be combined with any other object, including but not limited to other logos, words, graphics, photos, slogans, numbers, design features, or symbols.
- The logo must not be used on letterhead. No member outside of the Disabled Patriot Fund may use Disabled Patriot Fund letterhead. Logos are not to appear solely on any correspondence.
- All use of the logo must first be approved by the Disabled Patriot Fund prior to use.
- Neither the logo nor the Disabled Patriot Fund name may be used in any other company name, product name, service name, domain name, website title, publication title, or the like without prior approval by the Disabled Patriot Fund.
