This past year at A Child's Haven (ACH) has been one of growth and change. I am proud of the accomplishments of the ACH staff, Board of Directors, council members, and volunteers. One of our values is to keep the mission of the organization first. This is key to accomplishing all of our goals. In my year as Board President, I have had the privilege of seeing this value put into action.

At ACH, our primary goal is to provide access to our high quality behavioral health services to strengthen the entire family unit. We use a rigorous performance evaluation plan to measure the outcomes of our clients and make informed decisions about the program. We are committed to producing the results that demonstrate our effectiveness and community impact with a goal to be replicated in the future. The organization's continuous improvement systems have used both qualitative and qualitative data to make some significant improvements this past year.

The ACH team implemented a new curriculum, Incredible Beginnings (IB), into our Group Treatment Rooms to elevate the services we provide. This curriculum is an evidence-based program that is designed for children with severe social, emotional and behavioral issues. The IB program is the first of its kind in Greenville County and is approved by Substance Abuse and Mental Health Services Administration. The program restructure has resulted in improved access to services, staff retention, and client treatment goal attainment. I speak for the entire Board of Directors when I say that we are proud of the quality work that we are providing and look forward to supporting the staff's future accomplishments.

Lastly, the Board of Directors finalized and adopted the 2019 - 2022 Strategic Plan this past year. In order for this to happen, the Board, ACH staff, and other key stakeholders collaborated to establish six areas of focus including Program Excellence, Quality Workforce, Organizational Infrastructure, Community Awareness, Financial Sustainability, and Board Governance. We understand the importance of continuing to strengthen the legacy of our organization and the only way to keep ourselves accountable is to have a strong strategic plan to guide us.

Thank you for allowing me to serve as Board President this year.

Olivia's Story

During the first few years of Olivia's life, she was just like every other little girl. She loved to play and giggle. Olivia's parents and extended family were close-knit and were very involved in her life. Shortly after turning four and starting 4K, Olivia's teachers noticed she was becoming very withdrawn, had a hard time communicating verbally, and would throw tantrums when the class began a group activity.

After a Parent/Teacher conference, the teachers decided to try a few techniques in the classroom. A few weeks later, the teachers met with Olivia's parents once again and concluded Olivia needed to attend a facility that could dedicate more one-on-one time with her and referred the family to A Child's Haven (ACH).

Olivia's parents completed the ACH's intake process a week later and our Child and Family Therapist diagnosed Olivia with Unspecified Trauma — and Stressor — related Disorder. Olivia's parents were upset, but the therapist assured them that ACH would be able to connect them to every resource that they would need and that our staff are trained to work with children just like Olivia.

As expected, when Olivia first arrived at ACH she enjoyed playing by herself but when asked to participate in group activities with her peers, she would melt down. Olivia would not stop crying until one of the Clinical Providers took her to the "calming cube" where she could be by herself for a few minutes. After just a few weeks of treatment, Olivia learned that when she felt overwhelmed, she could take a break in the calming cube and collect herself. ACH staff equipped her parents with similar techniques to use when Olivia had an outburst at home.

There were many ups and downs in Olivia's treatment, and by the time she was discharged, she was ready to transition into public school. Olivia is now in kindergarten and her parents tell us that her communication skills and emotional responses improve every day.

A Child's Haven provides healing therapy for at-risk, young children with social and emotional challenges while fortifying their families and strengthening our community.

ACH services are trauma-informed and address the impact of **Adverse Childhood Experiences** (**ACEs**). Without multi-generational infant early childhood mental health services, such as therapeutic childcare, damage caused by childhood trauma can become permanent and lead to a lifetime of suffering that affects our entire community. Negative impacts include substance abuse, poor school performance, poor health outcomes, depression and violence. Together, we are lifting lives and reshaping futures.

WHAT ARE ACES?

Adverse Childhood Experiences, or ACEs, are traumatic events that occur during childhood. These events happen when a child experiences violence, abuse, or neglect; witnesses violence in the home; and/or has a family member attempt or die by suicide. Other ACEs are aspects of a child's environment that can undermine their sense of safety, stability, and bonding such as growing up in a household with substance misuse; mental health problems; or instability due to parental separation or incarceration of a parent, sibling, or other member of the household.





Who We Serve

THERAPEUTIC CHILDCARE & INDIVIDUAL THERAPY

Each therapeutic treatment team member has a bachelor's degree and many have Masters Degrees and other licenses. Working together, the team strengthens each child with a combination of Group Therapy, Individual Therapy, love, support and nutritious food.

- 1,247 individual therapy sessions were delivered to children.
- 82% children successfully discharged demonstrated measurable improved behavior. (CBCL scores)
- 12,614 hours of therapeutic childcare and clinical treatment provided.

FAMILY THERAPY & HOME VISITATION

Licensed Child and Family Therapists conduct regular Family Therapy sessions to set goals, reinforce methods taught at our center, improve family interactions, develop positive parenting skills, and improve the family's overall mental health.

- 1,687 family therapy sessions completed.
- 95% families reported that they have increased knowledge and gained skills to help their child.
- 100% families with a need identified at enrollment received an out of agency referral.

PARENT GROUP CONNECTION

Our parenting groups reinforce one-on-one home visit training and provide the tools caregivers need to raise healthy and successful children.

- 96% caregivers reported they deal with daily problems or challenges more effectively after program services.
- 98% caregivers reported "I feel more confident with my ability to parent my child."
- 99% families reported their expectations of provided services were met and/or exceeded.


