# 2026 AHIP/NABIP Medicare Certification

## OVERVIEW

- Completing either the 2026 AHIP or NABIP certification is **required** to market and sell 2026 plans.
- Both AHIP and NABIP may be accessed through the **Training Center** in your **Centene Workbench Portal**.
- As our valued partner, you are eligible for discounted pricing with either certification partner.
  - **AHIP** discounted pricing - \$125 vs \$175 (3 exam attempts).
  - **NABIP** member pricing - \$100 (6 exam attempts).
- Completed scores will be transmitted to your Centene Workbench Training Center. Wellcare does not accept PDF certificates of completion.





4. Follow the screen instructions to complete the AHIP Site registration/validation process for both first-time visitors and returning users.
5. Once the training and Final Exam are complete, to transmit your results to Centene, go to the **AHIP Course Completion** section within the AHIP Site. Select **Transmit** to the right of Wellcare/Centene to transmit your training results.

4. Follow the screen instructions to complete the **Sign In** or **Register** process by entering your **Email Address** or **National Producer Number (NPN)** and select the **Continue** button. This is required for both first time visitors and returning users.
5. Log onto the NABIP site by following these steps:
  - **Returning Users:** Enter your **Username** and **Password** and select the **Sign In** button.
  - **First Time Visitors:** Navigate to the bottom of the page to the **Prefer to create a new account instead?** section and select the **Click here to create one** link to proceed.
6. Prior to the start of the final exam, you will be prompted to indicate your carrier(s). In the **Identify Your Carriers** section, **Wellcare** will be auto populated as your carrier. Select the **Continue** button.

# 2026 Annual Certification Training (ACT)

## OVERVIEW

- Completion of 2026 Wellcare ACT is the second step in becoming certified to market/sell 2025 and 2026 Wellcare Medicare Advantage product offerings.
- All 2026 annual training requirements must be completed by **Sept. 30, 2025**, to market and sell 2026 Wellcare Medicare Advantage products and avoid suspension on **Oct. 1, 2025**.
- A score of **85%** or higher is required to pass the **Wellcare ACT Mastery Exam**.
- **2026 ACT Enhancements:**
  - Supplemental resources available throughout the course are combined into one comprehensive **toolkit** for post-training usage. Includes streamlined single-click access to state specific market highlights.
  - The 24-hr waiting period to retake the Mastery Exam is eliminated, with unlimited exam attempts available.



# 2026 Certification Update

- We are pleased to confirm that in response to feedback from our broker partners, there will be **no new contract signature requirements** for brokers already contracted with Wellcare in order to sell our 2026 plans.
- **What this means for you:**
  - Contracts signed by existing brokers last fall (2025) are **evergreen contracts** and will **renew automatically**, unless formally cancelled by either you or the plan.
  - New brokers will continue to sign their contract during onboarding, and it will also renew automatically as an evergreen contract.

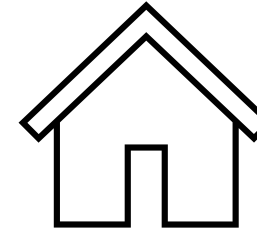

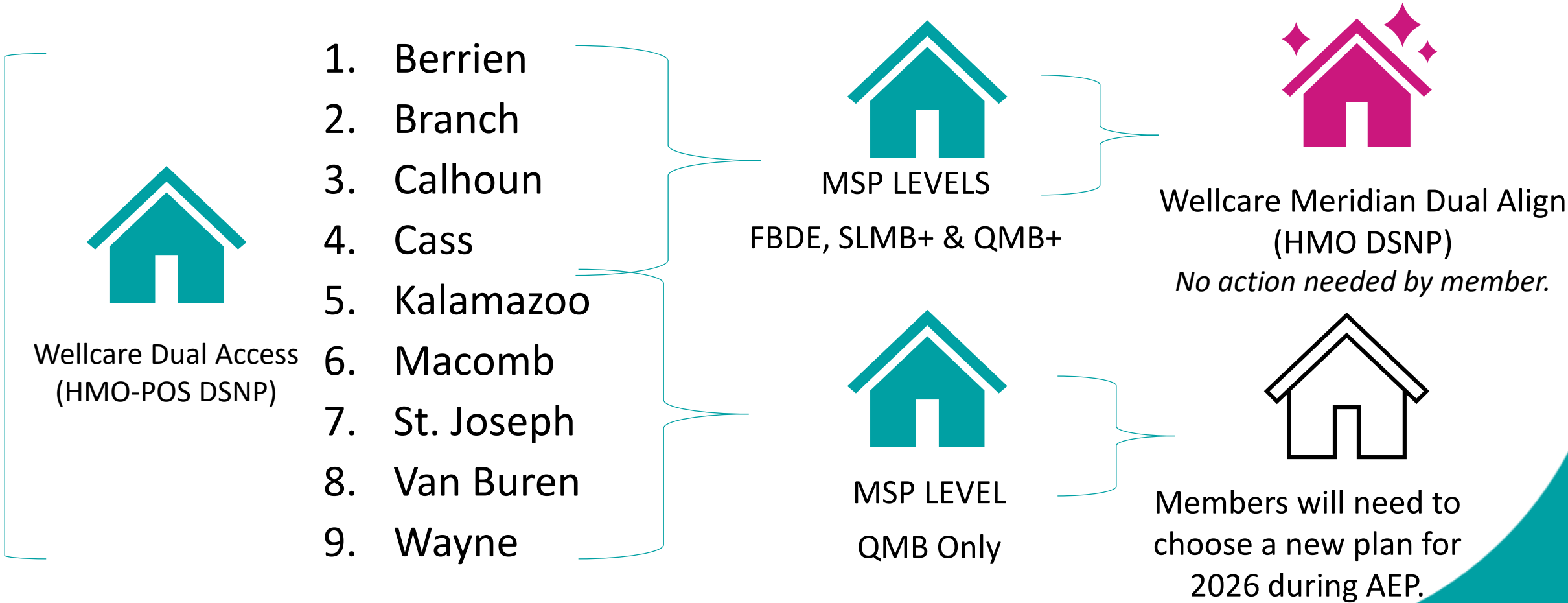

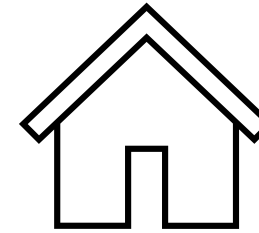

# D-SNP Types

## FIDE (Fully Integrated Dual Eligible) Special Needs Plan – INT SEP Eligible

Required to have exclusively aligned enrollment (EAE) and provide nearly all Medicaid services including:

- Long-term services and supports (LTSS)
- Behavioral health services
- Home health
- Durable Medical Equipment (DME)

## HIDE (Highly Integrated Dual Eligible) Special Needs Plan – INT SEP Eligible

MICHIGAN

- Unlike FIDEs, a HIDE is required to cover either LTSS or behavioral health services.
- HIDEs may exclude additional Medicaid services from their coverage.

## AIP (Applicable Integrated Plan) – INT SEP Eligible

- D-SNP model designation that operates with Exclusively Aligned Enrollment (EAE). AIP plans require a lead line of business, Medicare or Medicaid.
- Unified plan-level appeals and grievances processes are required in accordance with the Code of Federal Regulations (CFR).
- All FIDEs are AIPs by default. HIDE and CO plans can also be AIPs.

## CO (Coordination Only Dual Eligible) Special Needs Plan

MICHIGAN

D-SNPs that meet the minimum CMS requirements but are not qualified as a HIDE or FIDE. CO D-SNPs must:

- Hold a contract with the state Medicaid agency
- Coordinate the delivery of Medicare and Medicaid services
- Meet information sharing requirements

# D-SNP INT SEP Election Period Rules

## FULL BENEFIT DUAL ELIGIBLES (QMB+, SLMB+, FBDE)

- Monthly INT SEP eligible if all criteria is met:
  - Full benefit dual eligible
  - Enrolled in, or enrolling into (with a defined effective date), the Medicaid MCO from the same parent company *(exceptions in AZ, CA, DE, FL, IL, MI, NJ, OH, SC, TX)*
  - Enrolling into an available HIDE/FIDE/AIP in their service area

## PARTIAL DUAL ELIGIBLES & LIS ONLY (QMB, SLMB, QI, QDWI)

- NOT eligible for INT SEP
- Dual and LIS eligibles, regardless of level may choose any available D-SNP or TMA plan they qualify for during AEP, MA-OEP and ICEP or by using a valid SEP they meet the criteria for

Full or partial dual eligible or LIS beneficiaries may abandon their Medicare Advantage coverage and return to original Fee-For-Service (FFS) Medicare by enrolling into a standalone Prescription Drug Plan (PDP) monthly.

**Service Area:** Barry, Berrien, Branch, Calhoun, Cass, Kalamazoo, Macomb, St. Joseph, Van Buren, and Wayne Counties in Michigan

AIP plans operate with exclusively aligned enrollment and provide integrated Medicare and Medicaid benefits and member experience. To enroll in this plan, the beneficiary must be a full dual Medicaid beneficiary (FBDE, QMB+ or SLMB+). Upon enrollment into this plan, the beneficiary's Medicaid plan will be automatically changed to Meridian Health Plan. The beneficiary will not be permitted to keep their current Medicaid plan or services, as a condition of plan enrollment is for both Medicare and Medicaid services provided by the same legal entity.

The monthly INT SEP can be used year-round to enroll in this plan, regardless of current Medicaid carrier.

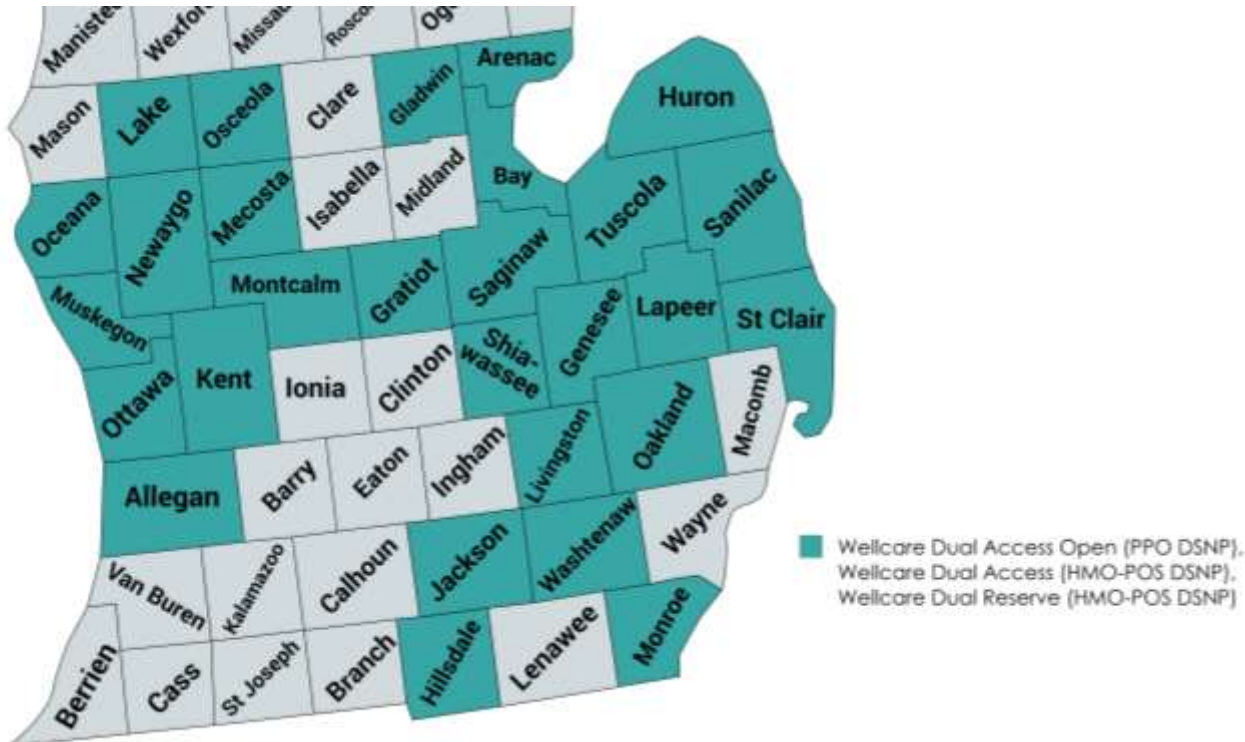

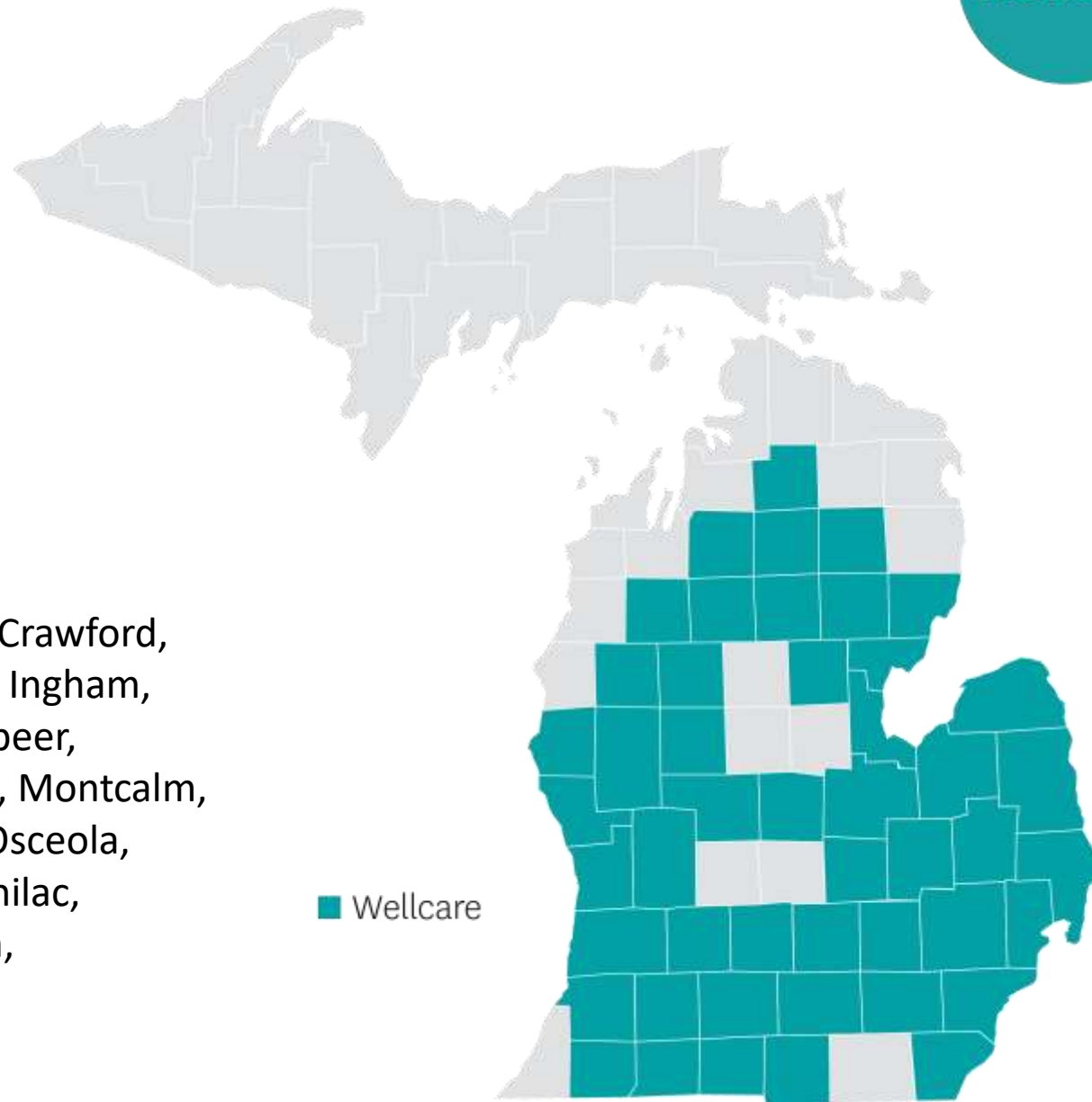
