Can I join this plan?

DEVOTED CHOICE GIVEBACK 002 MI (PPO) is a Preferred Provider Organization, or PPO plan. To join DEVOTED CHOICE GIVEBACK 002 MI (PPO), you must be entitled to Medicare Part A and enrolled in Medicare Part B. You also have to live in this plan's service area, which includes

these counties: Hillsdale and Washtenaw.

Can I see out-of-network providers?

Our plan allows you to see providers outside of our network (non-contracted providers). However, while we will pay for covered services provided by a non-contracted provider, the provider must agree to treat you, they must not be on any government sanction list, and they must participate in Medicare and accept Medicare reimbursement in order for the plan to cover Medicare-covered services. Except in an

emergency or urgent situation, non-contracted providers may deny care. In addition, you may pay a higher cost share for services provided by non-contracted providers.

 - Review the pharmacy directory to make sure the pharmacy you use for any prescription medicine is in the Devoted Health network. If the pharmacy is not listed, you may choose to select a new pharmacy for your prescriptions.

- This plan offers a Part B buydown. If you are responsible for a Part B premium, we will reduce your monthly Part B premium by \$152 per month. This reduction is set up by Medicare and administered through the Social Security Administration (SSA). Depending on how you pay your Medicare Part B premium, your reduction may be credited to your Social Security check or credited on your Medicare Part B premium statement. Sometimes reductions can take several months to be issued; however, you will receive a full credit.

 - Our plan allows you to see providers outside of our network (non-contracted providers). However, while we will pay for covered services provided by a non-contracted provider, the provider must agree to treat you.
