## **PROCLAMATION TOWN OF MAYODAN DECLARATION OF STATE OF EMERGENCY**

WHEREAS, on January 21, 2026, the Governor of North Carolina issued a State of Emergency for the State of North Carolina, including the Town of Mayodan, due to the anticipated impacts of a winter storm expected to occur in our area on January 24, 2026; and

WHEREAS, the Town of Mayodan anticipates significant snow and ice accumulations that are likely to result in hazardous weather conditions, including icy roadways, downed trees and power lines, and widespread power outages throughout the Town; and

WHEREAS, as a result of the above-described conditions, I have determined that there is an imminent threat of, or that existing conditions have caused or may cause, widespread or severe damage, injury, or loss of life or property, and that a declaration is necessary to support preparedness efforts and emergency response; and

WHEREAS, declaring a State of Emergency and imposing the restrictions and prohibitions ordered herein is necessary to maintain order and protect public health, safety, and welfare, and to secure property within the Town of Mayodan.

NOW, THEREFORE, pursuant to the authority vested in me as Mayor of the Town of Mayodan under Article 1A of Chapter 166A of the North Carolina General Statutes, I hereby declare the following:

**Section 1.** A State of Emergency is hereby declared within the jurisdiction of the Town of Mayodan.

**Section 2.** The emergency area covered by this State of Emergency shall be the entire jurisdiction of the Town of Mayodan.

**Section 3.** The following restrictions and prohibitions are imposed:

**A. Other:**

Citizens are strongly encouraged to remain off roadways during the impact and post-impact timeframes of the storm if reasonably possible, and to limit travel so as not to interfere with emergency response operations or utility and repair crews.

**Section 4.** All Town of Mayodan law enforcement officers, Town employees, and all other emergency management personnel subject to the Town's control are hereby ordered to cooperate in the enforcement and implementation of the provisions of this Declaration, all applicable local ordinances, state and federal laws, and the Rockingham County Emergency Operations Plan.


**Section 5.** This Declaration shall:

(a) be posted on the Town of Mayodan website and other appropriate media platforms to bring its contents to the attention of the general public;

(b) be filed with the Town Clerk; and  
(c) be distributed to other agencies and individuals as necessary to ensure proper implementation.

**Section 6.** This Declaration shall take effect on the 24<sup>th</sup> day of January 2026 at noon and shall remain in effect until modified or rescinded.
