Agenda Item D: Siren/Generator Maintenance: Jenna informed the board that the radio at the EMS/VFD station might need a new antenna or for the current antenna to be moved in order to sound the sirens with the specific codes. The Sheriff's department can set them off from the deputy vehicles. Jenna also went to the Roberts County Commissioners Court meeting on July 14<sup>th</sup> and spoke to the commissioners about putting one of the generators at the City Annex. The commissioners asked Jenna to get a quote on what it would cost to move the generator from the siren location and install at the Annex. A motion was made by Tresa Seuhs and seconded by Ryan McCoy for Jenna to get with North 40 Electric and get a quote. Motion carried all ayes.
