TERMS & CONDITIONS:

- 1) Vendor space is subject to space availability.
- 2) All booths selling or distributing food are required to provide a valid *MARICOPA COUNTY HEALTH PLAN PERMIT. The Certificate of Liability must cover Wickenburg Chamber of Commerce and the Town of Wickenburg and must be mailed with the vendor agreement. See exact wording on the rules sheet.
- 3) All food booths are required to have a working ABC fire extinguisher. (Provide photo of your booth)
- 4) Potable water is available onsite; vendors must supply their own container.
- 5) No promotional items may be distributed without the written permission of The Wickenburg Chamber of Commerce. **Must be provided in advance.**
- 6) Food Set-up: **Wednesday** (11/12/25) 8:00 a.m.-5:00p.m. All other set-up times: **Thursday** (11/13/25) 8:00 a.m.-5:00 p.m. **Friday** (11/14/25) 7:30 a.m.-10:00 a.m.
- 7) Gates open at 11:00 a.m. on Friday; Sat & Sun at 8:00 a.m.

- 8) Vendors are required to have their booths open from 11:00 a.m. to 5:00 p.m. on Friday, and from 9:00 a.m. to 5:00 p.m. on both Saturday and Sunday. Vendors are welcome to stay open beyond the required hours if they wish. However, booth activities must conclude at the end of the performances on Sunday.
- 9) All vendors are responsible for maintaining the cleanliness of their site.
- 10) All booth assignments are made by the vendor coordinator.
- 11) No vehicles will be allowed in the vendor area after initial setup.
- 12) Inspectors can no longer accept payments for Temporary Food Service Permits on site at events. All permits must be paid for by the vendors in advance. A copy must be sent to the Wickenburg Chamber of Commerce.

This is a family-oriented festival. All vendors are required to maintain a family-friendly and clean environment. Any vendor who, at the judgment of the Wickenburg Chamber of Commerce, is not in compliance, may be asked to leave immediately.
