Building Innovative Healthcare Teams Through LEGO® Serious Play® and Human-Centered Design

Garret Westlake, PhD — Vice Provost for Innovation and Strategic Design, Virginia Commonwealth University

INTRODUCTION TO INNOVATION AND DESIGN THINKING (90 MINUTES)

Combining design thinking and innovation with Lego Serious Play has helped Fortune 500 companies and health systems build high-functioning and creative teams that are both agile and innovative. Learners will explore the future of health through the perspective of human-centered design and be introduced to industry examples and the six foundational steps in the design thinking process. Learners will engage in individual and collaborative exercises to practice these steps using Lego bricks, prompting dialogue, encouraging reflection, improving problem-solving skills, and sparking imagination.

APPLICATION OF INNOVATION AND DESIGN THINKING (90 MINUTES)

Using LEGO bricks and innovation techniques from the introductory presentation, teams will engage in ideation and prototyping exercises that culminate in "superstories" which prepare teams to think creatively and catalyze strategic initiatives. Teams will deliver their superstories to the larger group and identify tangible steps for implementation following the conference.

Participants will leave with practical tools and techniques to improve collaboration, drive innovation, and create meaningful change in healthcare settings.

TRACK – Building Successful and Sustainable Rural Hospital Foundations - Grand Ballroom AD*John Goettler*

Rural hospitals in Wyoming face growing financial pressure while their communities continue to expect and deserve high-quality clinical care. As the costs of innovation, workforce recruitment, equipment, and facility improvement rise, philanthropy has become an essential strategy for strengthening services, sustaining access, and supporting long-term financial resilience. This presentation will show how rural hospital foundations can move beyond episodic fundraising to become strategic philanthropic partners by building the core capabilities required for long-term success. Hospital foundations are no longer simply “auxiliary fundraising groups.” Across the rural West, successful foundations serve as strategic partners

Jodi Eyigor will provide a national perspective on the federal policy issues shaping long-term care, including proposed changes to nursing home staffing standards moving through Congress, CMS's evolving approach to survey and star-rating methodology, and the administration's push to reduce regulatory burden while preserving quality and accountability.

TRACK – Trained APPs, Stronger Rural Hospitals: A Wyoming Workforce Success Story Grand Ballroom AD

Advanced practice providers are essential to sustaining rural healthcare access. When APPs receive specialized training, strong physician support, and ongoing mentorship, they can safely expand clinical capacity, strengthen care teams, and help rural hospitals maintain essential services. This session will highlight how Wyoming hospitals are successfully recruiting, training, and integrating APPs into rural care models. Panelists will share lessons from Cheyenne Regional Medical Center's APP internship program and rural sites across the state, including how procedural training, physician collaboration, and structured support prepare APPs to practice confidently in communities with limited workforce resources. Attendees will hear practical strategies for avoiding common hiring and integration challenges while building physician/APP models that improve staffing stability, support quality care, manage costs, and keep care close to home.
