in Miscellaneous Record 91, pages 262-305, pursuant to the
Horizontal Property Act, the Declaration, and the Powers of
Attorney provided by owners of units other than the Declarant.

The purpose of this amendment is to: 1) allocate percentage interests in the common areas between units and garages rather than as an aggregate sum; 2) correct a computational error; and 3) reflect changes in the percentage interest of units to which the Declarant holds title, as a result of reallocation of floor space caused by construction modification.

NOW, THEREFORE, EXHIBIT C to the Declaration of Horizontal Property Ownership of Woodcrest Court is recorded in Miscellaneous Book 91, page 294 is hereby amended by deleting said EXHIBIT C entirely and replacing the same with the following new EXHIBIT C:
