

## ST. ANTHONY ON THE LAKE SCRIP PROGRAM AGREEMENT

St. Anthony on the Lake School sponsors a gift card fundraising program called Scrip. The gift cards you purchase through the Scrip program generate rebates from the participating retailers. Fifty percent (50%) of the rebates generated will be retained by St. Anthony on the Lake School. The remainder of the rebates can be used in several ways (see below). With respect to amounts you elect to donate to St. Anthony on the Lake School or Choir, we will provide you with acknowledgement of such donations in accordance with sections 170(f)(8) and 170(f)(17) of the Internal Revenue Code.

### REBATE GUIDELINES

1. As stated above, Scrip generates funds by obtaining gift certificates from participating merchants at a discount and selling them at face value to program participants. The difference between these amounts is the "Scrip profit".
2. As a purchaser of Scrip, 50% of the total Scrip profit generated by your Scrip purchases can be used in one of five ways: (1) credited to your family's tuition costs at St. Anthony on the Lake School, (2) credited to another family's tuition costs at St. Anthony on the Lake School, (3) donated to St. Anthony on the Lake School, (4) donated to St. Anthony on the Lake's Choir or (5) paid to you as a cash rebate.
3. A minimum credit of \$10.00 must be earned in order to receive the credit.
4. Credits earned from July 1, 2025 through June 30, 2026 will be disbursed in July of 2026. If the purchaser chooses to use the credit for tuition costs, the tuition credit will reduce the designated family's tuition costs in the 2026-2027 school year. In the event that a participating family is leaving at the end of the school year, or their final child is graduating from St Anthony's, the monies will be donated back to St. Anthony on the Lake School.
5. If this contract is not returned by June 30, 2026, that family's credit will be donated to the school.
6. Participating families may accumulate tuition credits up to \$599.00. Your credit will be deducted from your family's first tuition payment of the school year. If your tuition credit is more than your family's first tuition payment, the remainder of the credit will be deducted from the future payments.
7. As the Scrip Tuition Credit Program evolves, additional guidelines, regulations, etc., may be identified and implemented at any time.
8. St. Anthony Scrip is not responsible for any lost or stolen certificates once in the purchaser's possession.
9. St. Anthony reserves the right of administrative interpretation regarding this plan.
10. You agree to indemnify the program against any loss incurred in connection with there being insufficient funds in your account to cover the checks or ACH transfers you issue to pay for your Scrip. We make no representations or warranties of any kind with respect to the Scrip. This agreement continues unless replaced by another and can be terminated by either of us upon 60 days advance notice to the other.

I understand that if I have elected to have my Scrip rebates applied to my family's tuition costs, once I no longer have any students in the school my rebates will default to a donation to the school unless I complete a new Program Agreement form.
