**If you've suffered an injury or illness; you may be entitled to compensation.**

### **Comcare claims**

Comcare is a national workers' compensation scheme that covers employees of federal government agencies and certain self-insured companies operating across Australia.

If you've been injured at work and your employer is covered under the Comcare scheme, you may be eligible for compensation. You don't need to prove fault—just that your injury or illness is work-related.

### **Injuries covered by the scheme**

You may be entitled to compensation for injuries sustained at work, or if your work significantly contributed to a disease or illness.

You can claim for:

- Physical injuries (including aggravations of existing injuries)
- Psychological injuries
- Injuries caused by travelling for work

Eligible workers include full-time, part-time, casual employees, and subcontractors.

### **What you can claim:**

- Weekly payments for lost earnings
- Medical expenses
- Domestic care and assistance
- Lump sum compensation
- Pain and suffering
- Death benefits (for eligible dependents)

### **Important Timeframes**

Under the Comcare Scheme, it's essential to notify your employer of your injury and lodge a claim without delay.

If your claim is rejected, you have **30 days** to request a Reconsideration from the insurer. They must then issue a Reviewable Decision.

If you disagree with the Reviewable Decision, you must file an application with the Administrative Appeals Tribunal (AAT) within **60 days** of the decision.
