Mayor Hatfield called the meeting to order. Council members present were Kathy Auck, Todd Musser, Heather Lessiter, Jackie Hatfield, Jesse Allison, and Rick Peters.

It was moved by Ms. Hatfield and seconded by Ms. Lessiter to approve the minutes from the June 10, 2024, Council meeting. Motion was approved.

Chief Falb gave the Fire report. Baughman Twp approached Marshallville Fire Department about possible coverage effective 01/01/2025.

Ordinance 24-11 was presented. It is an ordinance of the Village of Marshallville, Wayne County Ohio authorizing the mayor to enter into a contract with Valley View Spray Service LLC for the control of mosquitos within the village and declaring an emergency.

Ordinance 24-13 was presented. It is an ordinance of the Village of Marshallville, Wayne County Ohio authorizing the mayor to enter into contract with Most Paving Co. for street repairs and declaring an emergency.

It was moved by Mr. Peters and seconded by Ms. Hatfield to suspend the rules and declare an emergency for Ordinance 24-13. Motion approved unanimously.

It was moved by Ms. Lessiter and seconded by Ms. Auck to adopt Ordinance 24-13 effective immediately. Motion approved unanimously.
