## Minutes of Hardy Planning and Zoning Commission

November 1, 2022 – 5:30 p.m.

Mayor Ernie Rose, chairman of the Hardy Planning and Zoning Commission called the meeting to order at 5:36 p.m. Tuesday, November 1, 2022 at Hardy City Hall, 124 Woodland Hills Road, Hardy. The following commission members were present: Penny Allen, Phillip Horrell, Sue Taylor and Herbert Wise. Commission members Tony Berry and David Garland were absent. Attorney Grider and Recorder-Treasurer Darlene Wilson were also present.

Commissioner Allen made a motion to approve the minutes of the meeting of October 5, 2021, as written. Commissioner Horrell seconded the motion. Motion passed unanimously. No changes were made to the proposed agenda.

### NEW BUSINESS

Mayor Rose asked Recorder-Treasurer Darlene Wilson to discuss the Strategic Plan as passed in October 2021. Discussion was held among the commissioners about items listed in the current Strategic Plan. Margaret Lohr, a visitor affected by the Razorback Addition water system, spoke about the conditions of that well and she was told to contact the Woodland Hills POA President as the City is waiting for feedback from them before proceeding with any additional action. The commission agreed that a Strategic Plan public hearing, in accordance with Ordinance 2021-6, should be held before year-end and agreed on the same date as the next city council meeting which is December 6, 2022.
