## **RESOLUTION NO. 2022-R**

A RESOLUTION PROVIDING OPERATING BUDGETS FOR THE FISCAL YEAR 2023 BEGINNING JANUARY 1, 2023 AND ENDING DECEMBER 31, 2023 FOR THE CITY OF HARDY, ARKANSAS

**WHEREAS**, the City Council has made a comprehensive study and review of the proposed 2023 budgets; and

**WHEREAS**, the City Council is required to approve an operating budget for the General Fund, Street Fund, and the Hardy Water Works Fund for the year 2023; and

WHEREAS, the City Council finds the attached budgets reflect those anticipated revenues and expenditures for the fiscal year 2023 as accurately as possible for budgetary purposes and should be adopted as the budget governing city operations for January 1, 2023 through December 31, 2023;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HARDY, ARKANSAS THAT:

SECTION 1. This Resolution should be known as the Budget Resolution for the City of Hardy, Arkansas for the fiscal year 2023 and shall provide budgets for the General Fund, Street Fund, and Hardy Water Works Fund. All revenues set out herein are estimated and are subject to change; all appropriations are calculated on available revenues.

SECTION 2. The respective amounts of each and every expenditure and receipt herein proposed as the budgets of 2023 are approved by the City of Hardy, Arkansas and are hereby authorized and appropriated for the purposes herein set forth for the fiscal year 2023.

SECTION 3. The City Council hereby adopts the attached budgets as the Budgets governing city operations for January 1, 2023 through December 31, 2023.
