Commission met with Bill Cook to discuss culvert replacement at the Callao cemetery.

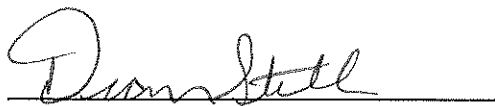

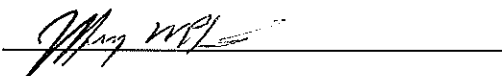

The County Commissioners were present or absent at said meeting as follows:

Commission met with Judge Rick Tucker, Judge Mike Greenwell and Juvenile Officer Megan Edgerton regarding the approximate \$39,000 increase in Juvenile legal fees. Also, present Krista Bruno, County Treasurer and Tammy Perkins, County Clerk. Currently, Macon County is paying \$137,277.00 in legal costs for GAL, parent legal, conflict attorneys and Juvenile Officer legal counsel. FY2026, their request is \$176,000. Additionally, there was an order to pay GAL attorneys \$250/per hour which increased from \$120/per hour in the last fiscal year. No explanation for the increases other than lack of attorneys in the area. The county commission agreed to move forward with the FY2026 request only if multi-year contracts could be signed with the attorneys.

It was agreed that if the County was ordered to pay attorney fees, proper documentation must be provided prior to payment being processed. Additionally, it was agreed that all GAL/indigent funds requested in the court's budget would be moved out of the court's budget into a separate area to better track all court ordered GAL/indigent attorney costs from all the judges in the circuit. It was requested that in the future, state, statutes would be followed by the Court. FY 2027, budget meeting has been set for December 3, 2026.

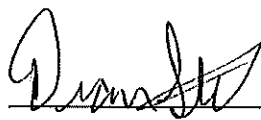

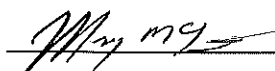

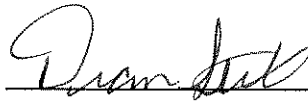
Commission held a budget meeting.

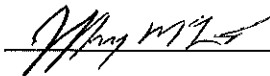

Commission had a budget meeting at 10:00. Jeff made a motion to approve 2026 budget, Dean 2nd, motion passed 3-yes and 0-no.

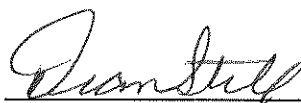
Commission approved a contribution of \$1000.00 to the Macon Senior Center to help provide meals to seniors.

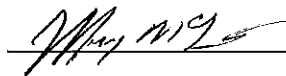

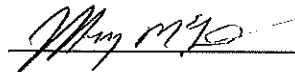
