Commission signed the progress invoice #12 project # BRO-R061 (001).


Commissioner received a call from Tracy Moore, MU University Extension, to discuss the internship with the county. They have an applicant in mind and will be in touch to set up an interview.

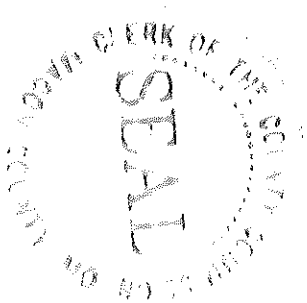
Commission met with Aaron Baker regarding the status of the old cabin located on the County Fairgrounds. It is scheduled to be demolished and disposed of.
