Commission signed invoice for GBS county insurance for additional claims funding in the amount \$100,000.00.


Commission received a call from Bruce Elam regarding a tube issue on Geyser Ave.

Commission met with Charmaine Willour discussing extensions for camping at the County Park.



Commission signed accounts payable and payroll.






