Commission met with Garritt Brinks, Doral Solar, to discuss road agreements.





Commission signed application for the Dept. Corps of Engineers for BRO-R061 (001) for old Hwy 36 bridge outside of Bevier.



Commission signed the Records Disposition for the County Clerk's office as per records retention schedule.


Commission met with Tracie Moore, University Extension, to provide updates on the recent activities with the Extension.
