
For the millions of Americans struggling to get back on their feet, stay in their homes, or find suitable housing in the future, many uncertainties remain.

As the major mortgage Government Sponsored Enterprises, the Federal Housing Administration (FHA), the VA, and USDA are all facing very high levels of seriously delinquent accounts (SDQs) – with the FHA facing the largest ever in its history, a staggering one million SDQs – the stakes and the level of scrutiny will be high.

- Responsive to community needs and to additional objectives as defined by the State.



### Travel Schedule for President Bush – September 10-11, 2001






#### Emma Booker Elementary School, Presidential motorcade arrives at 8:55 am, September 11, 2001






#### Second Plane Crashes into World Trade Center – 9:03 am












