- Deposit & Payment Refund Policy:** The Buyer understands and agrees that all deposits and any payments made toward the purchase of a puppy are 100% NON-REFUNDABLE under all circumstances. However, if the Buyer is unable to complete the purchase at this time, all funds paid may be transferred to a future litter with Blackwolf Newfoundlands for up to TWO (2) YEARS from the date the original deposit was received. After two (2) years from the original deposit date, any unused credit expires and all funds paid are forfeited. If at any time the Breeder chooses to cancel the sale, any funds paid will be refunded to the Buyer unless the cancellation is due to the Buyer violating the terms of this Agreement.
- Pick Order:** Pick order is determined by the date deposits are received. The Breeder reserves the right to first pick for breeder holds or working/service placements.
- Puppy Selection & Placement:** Placement is made with the puppy's best interest in mind. The Breeder reserves the right to refuse sale to any Buyer at any time. If the Breeder cancels the sale, payments made will be refunded unless Buyer has violated this agreement.
- Balance Due & Payment Schedule:** The Buyer agrees to the following payment schedule: Total Puppy Price \_\_\_\_\_

Half of the remaining balance is due when the puppy reaches 4 weeks of age. Amount due at 4 weeks is \_\_\_\_\_  
The remaining balance must be paid either \*No later than 7 days prior to pickup/transport, OR \* Paid IN CASH ONLY at the time of pickup. No electronic payments are accepted at pickup. Puppies will not leave Blackwolf until paid in full. Failure to make required payments on time may result in the puppy being placed with another family. All payments remain non-refundable but may be transferred to a future litter for up to 2 years.
- Pickup/Transport Estimated Pickup Date:** \_\_\_\_\_

- Registration/Breeding:** All of our puppies are ONLY placed with limited registration
- Buyer Acknowledgement:** Buyer confirms they are 18+ years, purchasing for themselves, and will provide proper lifelong care. The Breeder cannot guarantee adult size, color, or temperament outcomes as these are influenced by genetics and environment.
- Governing Law:** This Agreement is governed by the laws of the State of Minnesota.
- Entire Agreement:** This document is the full and complete Deposit, Reservation & Payment Agreement.
