- 1. Original copy of application, completed, \$100 fee paid
- 2. Household income verification (from all sources regardless of who pays it, who receives it, or why it was paid)
- 3. Identification for all members of the household
- 4. First mortgage commitment letter must have dollar amount listed.
- 5. SIGNED copy of First Time Home Buyer Rules and Requirements
- 6. I agree to pay for a \$40 lead inspection that is to be completed on my potential home.

(If there are hazards found, I agree to pay an additional \$40 for a re-inspection after remediation.) Additional fees may be charged if inspector is required to wait to be let into home.

Rate, origination fee, and points of the first mortgage must not be excessive for the type of mortgage obtained by the buyer: conventional, VA or FHA. No balloon payment or prepayment penalty allowed.
